Check-in: Players should check-in as early as possible and should arrive **NO LATER** than 30 minutes prior to the starting time for their earliest event. (Note: The venue opens at 8:00am).

Format:

- Giant RR. Players will snake drawn into 10 RR groups of 5 or 6 players.
- Top 2 players from each RR group will go to Group A, next 2 to Group B and last 2 to Group C. After second RR the top 2 players will advance to SE round to determine group champions
- Doubles will 3 RR groups of up to 4 teams in each group. The top two teams in each RR group will advance to SE round
- Maximum rating for U-2700 Doubles is 1700. Maximum rating for U-3000 Doubles is 1850. Maximum rating for U-3400 is 2000. Maximum rating for U-3700 is 2250.
- All matches are 11 points best of 5 games, except for the final match of Open Singles, which will be best of 7 games if asked.
- USATT rules and regulations will be enforced.

Event: Player may be removed from an event at any time should the Tournament Committee decide that the player is overqualified. The Tournament Committee also reserves the right to cancel any event if there are insufficient entries. Fees will be refunded for any cancelled events.

Equipment: Only USATT approved equipment will be used; Butterfly tables and white Nittaku Premium Three star 40+ Balls will be used.

Ratings: For event eligibility, the 9/05/2022 USATT web site published ratings will be used. Seeding will be based on most current ratings.
