REGISTRATION - Players must register with tournament officials at least **thirty minutes** before the scheduled starting time of their match.

MATCHES AND SEEDINGS-All matches will be three out of five except for the open which will be four out of seven from the quarter finals onward. Open Doubles Final will be four out of seven as well.
