Open Division : Entry Fee: \$120/Team; Team Rating: No Rating Restriction; Maximum Team allowed: 24
1st place: \$800/Team; 2nd place: \$400/Team; 3rd place and 4th place: \$200/Team

Play Date: Sunday, 11/26/2017

Teams will be seeded into preliminary round robins of 3 to 4 teams. The top one or two teams from each Round Robin will advance into a single elimination championship based on how many teams entered

A Division : Entry Fee: \$120/Team; Team Rating: Under 6050/Team , Maximum Team allowed: 24
1st place: \$800/Team; 2nd place: \$400/Team; 3rd place and 4th place: \$200/Team;

Play Date: Saturday, 11/25/2017

Each team will consist of three or maximum four players, where the combined rating for the three players must be 6050 or less. Player with lower than 1550 rating will enter event as 1550 rated player. Player with no rating will be given a rating of 1800 by default. Each team is allowed to have at the most one player with no rating.

Teams will be seeded into preliminary round robins of 3 to 4 teams. The top one or two teams from each Round Robin will advance into a single elimination championship based on how many teams entered.

B Division : Entry Fee: \$120/Team; Team Rating: Under 5350/Team; Maximum Team Allowed: 24
1st place: \$800/Team; 2nd place: \$400/Team; 3rd place and 4th place: \$200/Team

Play Date: Friday, 11/24/2017

Each team will consist of three or maximum four players, where the combined rating for the three players must be 5350 or less. Player must have USATT rating below 2050 to enter the tournament. Player with no rating will be given a rating of 1550 by default. Each team is allowed to have at the most one player with no rating.

Teams will be seeded into preliminary round robins of 3 to 4 teams. The top one or two teams from each Round Robin will advance into a single elimination championship based on how many teams entered

Order of Play: Each Team match only allowed 3 players to play and no one can play more than two matches.

When the team match is called, each team will report to the Control Desk where one team will be designated the A/B/C team and the other X/Y/Z. The first three matches are singles matches, in which each player from each team must play once, in any order chosen by each team. The first team to win three individual matches wins the team match. The fourth match, if necessary, will be a doubles match. The fifth match, if necessary, will be a singles match; whoever scores 5 points first will win the match, with no deuce allowed. Fifth match will not be recorded for USATT rating purpose. Each team can choose any player for the fourth match. The player for the fifth match, if necessary, cannot be the player for the fourth match.

Ratings: Your official rating for this tournament will be the one listed on the USATT website as of Thursday, November 16, 2017

Entry Deadline: Teams MUST register and prepay (no exceptions). All team entries must be received by Thursday, November 16th, 2017

比賽規則：每一支隊伍由三至四人組成，最高三人加起來的美國乒協積分不能超過 6050 分。個人最低分數不能低於 1550 分，沒有美國乒協積分的球員，其積分將自動設定為 1800 分。低於 1550 分的球員將自動設定為 1550 分。每一隊最多只能有一位沒有積分的球員。最先贏得三場比賽的隊伍獲勝。

第一階段，小組循環賽。每個小組分別由 3-4 個隊伍組成。第二階段，根據報名的隊決定各小組 1 或者 2 名進入第二階段的淘汰賽，最終產生團體賽的名次。

比賽獎金：第一名：\$800 / 隊； 第二名：\$400 / 隊； 第三，四名：\$200/ 隊

B 級：11/24/2017 比賽，報名費 \$120/隊；報名限 24 隊；團體分數限制：5350 以下；

比賽規則：每一支隊伍由三至四人組成，最高三人加起來的美國乒協積分不能超過 5350 分。個人最高分數不能高於 2050 分，沒有美國乒協積分的球員，其積分將自動設定為 1550 分。每一隊最多只能有一位沒有積分的球員。最先贏得三場比賽的隊伍獲勝。所有美國乒協的規例均有效。

第一階段，小組循環賽。每個小組分別由 3-4 個隊伍組成。第二階段，根據報名的隊決定各小組 1 或者 2 名進入第二階段的淘汰賽，最終產生團體賽的名次。

比賽獎金：第一名：\$800 / 隊， 第二名：\$400 / 隊， 第三，四名：\$200/ 隊

比賽順序：每場比賽最多 3 人出場。每場比賽每人不能出場超過 2 次。

比賽雙方分為 A/B/C 隊和 X/Y/Z 隊。前三場單打以及第四場雙打均為五局三勝制，每隊可以自由決定前三場出場隊員順序，每人只能打一場單打。第四場為雙打，各隊可以自由選擇第四場雙打出場的人。第五場為一局五分制比賽，一人發一球，先拿到五分的一方獲勝，沒有 deuce。參加雙打的人不能打第五場比賽。
