**Rules and Policies**

- **Eligibility.** This tournament is a USATT sanctioned event. USATT membership required. USATT rules will be enforced. All decisions by the tournament director shall be final and contestants upon entering agree to abide by them. Tournament Officials have the responsibility to caution players, coaches and spectators for violation of these rules. USATT Dress Code applies to all events. No white clothing allowed.
- **Entry Deadline.** April 15, 2017. Online entries, prior to April 9, 2017 will receive an early-bird discount, whereby the \$12 admin fee will be waived, providing the entry is paid in full by April 9, 2017. Payments postmarked after April 15, 2017 may not be accepted.
- **Registration.** Players must check in at registration no later than 20 minutes before your first event. Match time is default time.
- **Format.** All matches are best of five (5) games to eleven (11) points, except for the following events: City Open Singles single-elimination rounds, will be the best of seven (7) games; also see Hardbat section below.
- **Age Limits.** For the 18 & Under event, participant must be under their respective age on 4/22/2017. Proof of age must be readily available at the tournament (or prior to). For Adult events, participant must be the respective age as of December 31, 2017. Players who are over / under the age limit, of an event, will automatically be entered in the correct age event.
- **Qualification Cutoff.** For event eligibility the ratings as of March 24, 2016 will be used. Seeding will be based upon the latest available ratings.
- **Unrated Players (players without a USATT rating).** Unrated players may enter any Sanctioned event for which they are otherwise eligible. Unrated players will not advance from any rating restricted round robin. Unrated players at qualification time cannot enter any rated doubles events. The Tournament Director will be the final authority on a player's rating status.
- Players may enter a maximum of six (6) events per day and one (1) event per time slot.
- **Hardbat.** Hardbat rules will be used, as adopted by the USATT Classic Table Tennis Committee. See www.hardbat.com. Matches will be the best of 3 games to 21 points. Balls: Nittaku Premium 40+ (white.)
- **Cancellations.** Any event entry not paid in full by 4/15/2017 is ineligible to play in that event. A \$15 processing fee will be charged to any participant who withdraws from the tournament after April 15, 2017. Withdrawal notification must be submitted, in writing, to WMiTT Corporate Office, in order to receive a refund. A credit will be issued, for withdrawals prior to 4/15/2017, to be applied at any future WMiTT events. A credit slip is non-transferrable, non-refundable, totally and permanently irrevocable and has no cash value. See credit certificate for expiration date details.
- Tournament management reserves the right to modify, combine or cancel events, and limit the number of participants per event. If the event is cancelled your fee will be refunded. Cash prizes will be paid at the tournament, or within 30 days thereafter, if applicable. All other awards earned, will be distributed at the tournament only and while the supply lasts, with best efforts and planning.
- Any image, photographic or otherwise, taken of the tournament play or within the venue is the joint property of USATT and WMiTT (West Michigan Table Tennis.)
