Event Information

1. Event #s 1-16; 19-23; & 25-26, All players must be current USATT members or purchase a tournament pass. (see membership information on entry portion). Memberships can be purchased at the tournament
2. Events #18 (U-3800 Doubles) and #29 (Handicap) players must have a current USATT rating (within 3 years).
3. Event #24 (Recreational), entry is for players who have never been rated.
4. Events #24, #27, & #28 on-site registration is permitted
5. Events #25 and #26 are Giant RR events. Players will be seeded in RR groups of 8 with top 4 in each group advancing to single elimination. Be prepared to play 6 to 10 matches.
6. Event #27 is Hardbat and is unrated. Rules are at www.hardbat.com. Matches are 2 of 3 games to 21 points
7. Event #28 is a team event for members of the same family; parent/child, siblings, grandparent/grandchild, etc. Teams are two players (rated or unrated players) and a team match will be best of 5 separate matches, A vs. X, B vs. Y, Doubles, A vs. Y, and B vs. X. The round is over when one team has 3 wins
8. Event #29 (41 Point Handicap) is unrated, single elimination and open only to rated players. Players rated 2300 and over have free entry in this event.
9. All matches will be 3 of 5 games, except for event #17 (Open Doubles), which is 4 of 7; event #1 (Open Singles), which is 4 of 7 in the quarters, semis, and finals. Event #29 (handicap) is one game to 41 points.
10. Format will be RR groups of 4 with top player advancing in all events, except Giant RR events (#25 and #26). Open Doubles and Handicap are single elimination.
11. Unrated players may enter any event (except events #18 and #29) **BUT** will not advance from their round robin in events #2 through #16, #25 and #26.
12. Depending on entries, top seeded players in Open singles may be placed directly into the elimination round.
13. Age cutoff for events #19 and #20 is 9/15/17; for events #21 and #22 is 12/31/17.
14. Any event starting 6:00 PM or later on Saturday **MAY** carryover elimination rounds to Sunday.
15. Players may not enter more than one event with the same starting time. **Default time is start time.**
16. Tournament management may modify, combine, or cancel events, limit total entries or total entries by event.

Additional Information

17. All players pay \$10 registration fee, except in the Family Team event and are not competing in other events.
18. All USATT rules will be enforced including approved tie-breaking rules. Boosters or glue with VOC's are not permitted. No prizes awarded for splits, dumps, defaults, or no-shows. No white shirts, shorts or skirts.
19. Ratings as of 8/1/17 will be used for event eligibility; seeding will be based upon latest available ratings.
20. No refunds after published entry deadline of September 8, 2017.
