Please check-in at tournament desk no later than 15 minutes prior to your start time. Default time is start time. All matches will be best 3 out of 5 games to 11 points. Events will consist of 4 player round robin groups, followed by single elimination. Top two players in RR advanced to single elim in events 1, 2, 3. Only RR winner advances in events 4-8. Unrated players must provide estimated rating and may not advance from RR stage in events 4-7.	All USATT regulations apply including dress code (no white shirts/shorts). No prizes awarded for splits, dumps, defaults, or no-shows. USATT approved tie-breaking procedures will be used. Events may be modified at the discretion of the Tournament Committee. All decisions are final. USATT rating as of 2/8/2026 will be used for event eligibility. Latest USATT rating as of 6/13/2026 will be used for seeding. All matches will count towards USATT Rating except for Doubles.	All players must show proof of USATT Silver Membership at the time of registration.
