DATE: Sunday, July 16, 2023 Door opens at 8:30 am, play begins at 9:30 am. Please check in at the control desk by 9 am.

LOCATION: Los Angeles Table Tennis Assoc. (LATTA), 10180 Valley Blvd., El Monte, CA 91731 (behind the El Monte Car Wash)

TOURNAMENT EQUIPMENT & BALL: 12 Butterfly tables used for Tournament and 2 tables are open for warm-up, practice. Nittaku Premium 3 star plastic balls

TOURNAMENT FORMAT: The preliminaries will begin with a round robin group of 3 to 5 Teams. 2 Teams advance to single elimination playoffs. All USATT regulations and rules apply. All final rules are subject to LATTA.

RATINGS AND DEADLINE: The latest ratings from USATT ratings database as of July 2, will be used for qualifications. Maximum rating for a player is 2125. All team entries must be received by Friday, July 14, 2023. First come, first serve.

<u>UNDER 5750 TEAM</u>: Entry Fee: \$130/Team; Maximum Team Allowed: 20 (First come, first serve!!!)

1st place: \$700/Team; 2nd place: \$375/Team; 3rd (semis): \$200/Team

Each Team will consist of three or maximum of four players, where the combined rating for the three players must total 5750 or less. Player must have USATT rating 2125 & under to enter the tournament. Player with no rating will be given a rating of 1875 by default. Each team is allowed to have at the most, one player with no rating. Teams will be seeded into preliminary round robins of 3 to 5 Teams. The top two Teams from each round robin will advance into a single elimination playoffs.

Order of Play: Each Team match only allowed 3 players to play and no one can play more than two matches. When the team match is called, each team will report to the Control Desk where one team will be designated the A/B/C team and the other X/Y/Z. The first three matches are singles matches, in which each player from each team must play once, in any order chosen by each team. The first team to win three individual matches wins the team match! The fourth match, if necessary, will be a doubles match. The fifth match, if necessary, will be a one game singles match. Whoever scores 5 points first, will win the match, with no deuce allowed. Each team can choose any player for the fourth match. The player for the fifth match, if necessary, cannot be the player for the fourth match. Anyone can win in the fifth match, since only play up to 5 points! Super exciting & intense!
