FORMAT: All rating events start with a round robin. 2 players may advance from each group, followed by a single elimination playoff. Doubles event is round robin (RR) & NO maximum player rating.

OFFICIAL EQUIPMENT: White Nittaku premium 3 star poly balls. 14 ITTF approved tables and nets (Butterfly, Joola). Red floor mat on all courts.

RULES:

--All USATT regulations, including equipment, conduct, dress, and language apply.

--Players may not enter 2 events with identical starting times. --All matches are 11 pt. games, best 3 out of 5 games. 2 minute warm-up rule before match will apply.

--Players must register at least 30 minutes before starting time. All decisions by the tournament referee & committee are final.
