*Swaythling Cup format - Best 5 of 9 singles matches. A team has 3 to 5 members;3 playing each round (A, B, & C and X, Y, & Z). Each team member plays up to 3 singles matches per round. Matches are 3/5 games to 11 points.

*The top-rated player on teams with a rating difference of 400 or more between the top-rated and the lowest rated must compete in at least 20% of the matches after the preliminary round.
