### Competition Format

\*8 to 10 teams for Divisions 2-6; 1st round is placement round; then round robin; Division 1 has 6 to 8 teams round robin with finals at 2 pm on Sunday. ***\*All teams in Division One receive medals and prize money. \$350 for 4th; \$250 for 5th; \$200 6th; \$100 for 7th & 8th!***

\*Swaythling Cup format - Best 5 of 9 singles matches. Teams have 3 to 5 members; 3 playing each round (A, B, & C and X, Y, & Z). Each team member plays up to 3 singles matches per round. Matches are 3/5 games to 11 points.

\*The top-rated player on teams with a rating difference of 400 or more between the top-rated and the lowest rated must compete in at least 20% of the matches after the preliminary round.

All USATT regulations apply including dress code. **No prizes awarded for splits, dumps, defaults, or no-shows.** USATT approved tie-breaking procedures will be used. Events may be modified at the discretion of the tournament director. All decisions of the tournament committee are final. Latest available ratings used for seeding. Unrated players may enter and advance. Estimated ratings used for unrated players.

### Tournament Equipment & Conditions

Only USATT approved equipment will be used with Joola 3000 SC tables & Joola 40+ three-star white plastic balls.

GerFlor or wood flooring with excellent lighting for all divisions. Venue opens at 5 pm on Friday for practice.

### Refunds

No refunds after the deadline date, May 14 2023. \$100 Admin fee applied to all refunds. Refunds processed 30 days after tournament.
