Format: All matches are 3 out of 5 games to 11 points, except for Open Single Finals (best 4 out of 7 games).

• Policies: All USATT regulations apply including dress code. No prizes awarded for splits, dumps, defaults, or no-shows. Events may be modified at the discretion of the Tournament Director. Do not enter 2 events with same starting time. USATT approved tiebreaking procedures will be used. No white shirts, shorts, or skirts.

• Proof of Membership: Must show USATT proof of membership for events 1-14. Memberships and renewals sold at the event. All players must either be current members or purchase a tournament pass for \$20. Membership fees: Adults \$75; Juniors/College \$45.
