Airports: SFO (San Francisco International Airport) – 25 min drive, SJC (San Jose International Airport) – 15 min drive

Check-In: Starts 8:30 AM on Saturday, and 7:30 AM on Sunday

Rating Eligibility Date: June 1, 2018

Equipment: Only USATT approved equipment used; 8-9 DHS Rainbow tables; Nittaku 40+ Premium Balls.

Refunds: No refunds after July 7, 2018 unless the tournament is cancelled. Refunds given for events cancelled by management.

Format: All matches are 3 out of 5 games to 11 points, except Men/Women Singles Semi-Finals and Finals is best 4 out of 7 games.

- Policies: All USATT regulations apply including dress code. No prizes awarded for splits, dumps, defaults, or no-shows. Events may be modified at the discretion of the Tournament Director. Do not enter 2 events with same starting time. USATT approved tiebreaking procedures will be used. No white shirts, shorts, or skirts. If playing in ONLY doubles events, then court/admin fees are waived.
- Proof of Membership: Must show USATT proof of membership for events 1-17. Memberships and renewals sold at the event. All players must either be current members or purchase a tournament pass for \$20. Membership fees: Adults \$75; Juniors/College \$45.
