• Policies: All USATT regulations apply including dress code. No prizes awarded for splits, dumps, defaults, or no-shows. Events may be modified at the discretion of the Tournament Director. Do not enter 2 events with same starting time. USATT approved tiebreaking procedures will be used. No white shirts, shorts, or skirts. All matches are 3 out of 5 games to 11 points.
