**Equipment** 16 ITTF-approved Butterfly Centerfold tables on red sport floor, white Butterfly 3-Star R40+ plastic balls.

**Rules** All USATT regulations apply. Only ITTF and USATT approved equipment will be allowed.

Rating cutoff date is June 18, 2026. Unrated player may enter any event but cannot advance.

Player cannot enter multiple events that have the same start time.

Player who enters 3 Singles events cannot enter Doubles event.

**Eligibility** Active USATT membership is required.

**Format** The U1300, U1600, U1900, and U2100 events are USATT sanctioned.

The Open Singles event is non-sanctioned.

All matches will be the best 3 out of 5 (11-point) games.

**Round 1:** Round robin groups will be played. Top two players of each group will advance to Round 2.

**Round 2:** Matches will be played in single-elimination format. Cash prize events must be played and completed to earn the money.

**Notes** **Finals Match Integrity & Prize Money:** To maintain the integrity of the competition, unless approved by the tournament director, all matches must be played to their natural conclusion. Failure to complete a match to its natural conclusion will result in the forfeiture of the entire prize pool for that event for the player(s) unwilling to complete the match. Any agreement between players to split prize money in lieu of playing a match is strictly prohibited and will result in the disqualification of both players from the event and the forfeiture of all associated prize money.

**Sandbagging:** If a player in an event is deemed underrated to the point of creating a deficient draw, a decision may be made by the tournament director and referee to remove a player from the event and refund their money or allow them in a higher rated event.

**Enter Online** ATTC accepts tournament entry via [www.omnipong.com](http://www.omnipong.com) website. You must register with a valid email and pay online. Register early and pay the entry fee to secure your spot. Our tournaments generally fill up quickly.

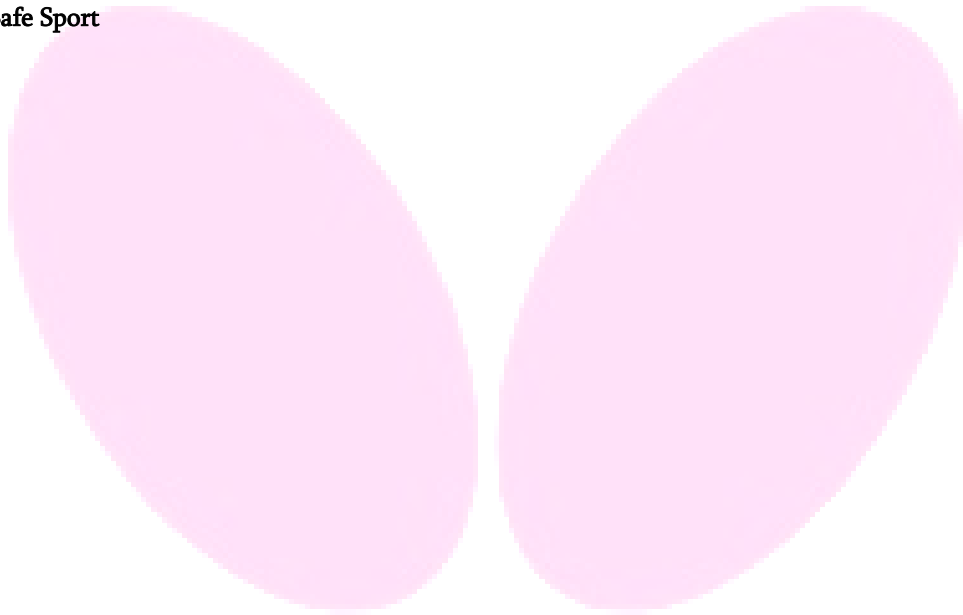

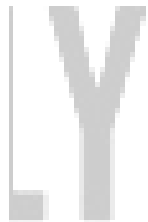

ACKNOWLEDGE, agree, and represent that I and/or my minor understand the nature of Table Tennis Activities and that I and/or my minor child are qualified, in good health, and in proper physical condition to participate in such Activity. I further agree that if at any time I believe conditions or equipment to be unsafe, I and/or my minor child will immediately discontinue further participation in the Activity.

3. FULLY UNDERSTAND that (a) TABLE TENNIS ACTIVITIES INVOLVE RISKS AND DANGERS OF SERIOUS BODILY INJURY, INCLUDING PERMANENT DISABILITY, PARALYSIS AND DEATH, HARASSMENT, EXPOSURE TO INAPPROPRIATE CONDUCT AND LANGUAGE ("RISKS"); (b) these Risks and dangers may be caused by me and/or my child's own actions, or inaction, or the actions or inaction of others participating in the Activity, the condition in which the Activity takes place, or THE NEGLIGENCE OF THE "RELEASEES" NAMED BELOW; (c) there may be OTHER RISKS AND SEVERE SOCIAL AND ECONOMIC LOSSES either not known to me or not readily foreseeable at this time; and I FULLY ACCEPT AND ASSUME ALL SUCH RISKS AND ALL RESPONSIBILITY FOR LOSSES, COSTS, AND DAMAGES I and/or my minor child incur as a result of my participation in the Activity.

HEREBY RELEASE, DISCHARGE, AND COVENANT NOT TO SUE USA TABLE TENNIS, their respective administrators, directors, agents, officers, officials, volunteers, and employees, other participants, any sponsors, advertisers, and if applicable, owners and lessors of premises on which the Activity takes place, (each considered one of the "RELEASEES" herein) FROM ALL LIABILITY, CLAIMS, DEMANDS, LOSSES, OR DAMAGES ON MY ACCOUNT CAUSED OR ALLEGED TO BE CAUSED IN WHOLE OR IN PART BY THE NEGLIGENCE OF THE "RELEASEES" OR OTHERWISE, INCLUDING NEGLIGENT RESCUE OPERATIONS; AND I FURTHER AGREE that if, despite this RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK, AND INDEMNITY AGREEMENT I and/or my minor child, or anyone on my and/or my minor child's behalf, makes a claim against any of the Releases, I WILL INDEMNIFY, SAVE, AND HOLD HARMLESS EACH OF THE RELEASEES from any litigation expenses, attorney fees, loss, liability, damage, or cost which may incur as the result of such claim.

**ENTRY BLANK TEMPLATE FOR USATT SANCTIONED TOURNAMENTS**

I understand USATT's Safe Sport Policy including the organization's Coaching Policy, which requires that all persons who are engaged in coaching activities at USATT Affiliated Member Clubs and/or USATT Sanctioned Tournaments, except parents or legal guardians coaching their own children, must be fully Safe Sport Compliant, which includes completing SafeSport Training offered by the US Center for SafeSport every year and undergoing a criminal background screen every two years.
