Saturday events: Two Stage Round Robin

Under 1600 - Two Stage RR, 9:30a

Over 1600 – Two Stage RR, 3:00p

24 player limit for each event

Format for both Under 1600 & Over 1600:

First Stage: 4 groups of 6 players compete in Round Robin.

Second Stage: A, B & C divisions. Top 2 finishers in 1st stage group advance to A division, 3rd & 4th place finishers advance to B division, 5th & 6th place finishers advance to C division. Each division has 2 groups of 4 players.

Top two from each group in the Second Stage move to Semi-Finals and Finals.

All singles events will be modified RR best of 3 out of 5.

Format and eligibility change can occur at tournament committee discretion.

Start Time: U-1600 event play begins at 9:30 a.m. EDT. Gym opens at 8:00a and all players should be checked in by 9:00a.

USATT TOURNAMENT PARTICIPANT WAIVER IN CONSIDERATION of being permitted to participate in any way in USA Table Tennis sanctioned events, I and/or minor child, our personal representatives, assigns, heirs, and next of kin, I: ACKNOWLEDGE, agree, and represent that I and/or minor-aged child understand the nature of Table Tennis Activities, including but not limited to risks involved in the sport itself together with all risks, known and unknown, associated with gatherings of people ("Activities"), including the exposure to COVID-19, coronavirus, or other infectious organisms or diseases; and that I and/or minor child are qualified, in good health, and in proper physical condition to participate in such Activities. I further agree that if at any time I believe conditions or equipment to be unsafe, I and/or minor child will immediately discontinue further participation in the Activities. FULLY UNDERSTAND that (a) TABLE TENNIS ACTIVITIES INVOLVE RISKS AND DANGERS OF SERIOUS BODILY INJURY, INCLUDING PERMANENT DISABILITY, PARALYSIS, DISMEMBERMENT, AND DEATH ("RISKS"); (b) these Risks and dangers may be caused by me and/or minor child's own actions, or inaction, or the actions or inaction of others participating in the Activities, the condition in which the Activities takes place, or THE NEGLIGENCE OF THE "RELEASEES" NAMED BELOW; (c) there may be OTHER RISKS AND SEVERE SOCIAL AND ECONOMIC LOSSES either not known to me or not readily foreseeable at this time; and I FULLY ACCEPT AND ASSUME ALL SUCH RISKS AND ALL RESPONSIBILITY FOR LOSSES, COSTS, AND DAMAGES I and/or minor child incur as a result of my participation in such Activities.
