USATT regulations will apply. USATT membership is required. Purchase Gold/\$100 or Silver/\$50 membership at www.usatt.justgo.com before registering for the tournament at www.omnipong.com.
USATT-approved equipment will be used: 7 Butterfly Octet tables; Butterfly R40+ 3 star (white) plastic balls, rubberized flooring on all tables. All matches will be best three out of five games. Preliminary groups will have (3 or 4) players in each group. The (2) top finishers in each preliminary group will advance to a single-elimination bracket.
Rating event eligibility is determined by a player's rating on the registration deadline, September 17, 2026.
Junior event eligibility is determined by player's age on September 19, 2026.
Senior event eligibility is determined by player's age on December 31, 2026.
Unrated players may advance beyond preliminary groups in rating events if Tournament Director is able to assign them an estimated rating.
Check-in at least 30 minutes before the start of your first event. Tables will be available for practice at 8 AM.
