 USATT-approved equipment will be used: 13 Killerspin MyT10 tables and Butterfly G40+ three star(white) balls.
 Events with insufficient entries may be canceled. Fees will be refunded or you will be placed in the next higher rating event.
 All matches will be best three out of five games. The top finisher in each preliminary round-robin will advance to a single-elimination round.
Junior event eligibility is determined by the player's age on April 8, 2017.
Seniors (40+) event eligibility is determined by the player's age on December 31, 2017.
Unrated players cannot advance beyond preliminary round-robins in rating events. Unrated players must purchase a USATT membership or a \$20 Tournament Pass.
Check-in at least 30 minutes before the start of your first event. Tables are available for practice one hour prior to start of first event.
