Waiver - Spin & Smash Table Tennis & Ping Pong Club

1. I and/or my minor child, our personal representatives, assigns, heirs, and next of kin:

ACKNOWLEDGE, agree, and represent that I and/or my minor understand the nature of Table Tennis Activities and that I and/or my minor child are qualified, in good health, and in proper physical condition to participate in such Activity. I further agree that if at any time I believe conditions or equipment to be unsafe, I and/or my minor child will immediately discontinue further participation in the Activity.
3. FULLY UNDERSTAND that (a) TABLE TENNIS ACTIVITIES INVOLVE RISKS AND DANGERS OF SERIOUS BODILY INJURY, INCLUDING PERMANENT DISABILITY, PARALYSIS AND DEATH, HARASSMENT, EXPOSURE TO INAPPROPRIATE CONDUCT AND LANGUAGE (“RISKS”); (b) these Risks and dangers may be caused by me and/or my child’s own actions, or inaction, or the actions or inaction of others participating in the Activity, the condition in which the Activity takes place, or THE NEGLIGENCE OF THE “RELEASEES” NAMED BELOW; (c) there may be OTHER RISKS AND SEVERE SOCIAL AND ECONOMIC LOSSES either not known to me or not readily foreseeable at this time; and I FULLY ACCEPT AND ASSUME ALL SUCH RISKS AND ALL RESPONSIBILITY FOR LOSSES, COSTS, AND DAMAGES I and/or my minor child incur as a result of my participation in the Activity.
4. HEREBY ACCEPT AND ASSUME ALL SUCH RISKS, KNOWN AND UNKNOWN, AND ASSUME ALL RESPONSIBILITY FOR THE LOSSES, COSTS, AND/OR DAMAGES FOLLOWING SUCH INJURY, DISABILITY, PARALYSIS, OR DEATH, EVEN IF CAUSED, IN WHOLE OR IN PART, BY THE NEGLIGENCE OF THE “RELEASEES” NAMED BELOW;

HEREBY RELEASE, DISCHARGE, AND COVENANT NOT TO SUE Table Tennis Training Centers, LC (dba Spin & Smash Table Tennis & Ping Pong Club), their respective administrators, directors, agents, officers, officials, volunteers, and employees, other participants, any sponsors, advertisers, and if applicable, owners and lessors of premises on which the Activity takes place, (each considered one of the “RELEASEES” herein) FROM ALL LIABILITY, CLAIMS, DEMANDS, LOSSES, OR DAMAGES ON MY ACCOUNT CAUSED OR ALLEGED TO BE CAUSED IN WHOLE OR IN PART BY THE NEGLIGENCE OF THE “RELEASEES” OR OTHERWISE, INCLUDING NEGLIGENT RESCUE OPERATIONS; AND I FURTHER AGREE that if, despite this RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK, AND INDEMNITY AGREEMENT I and/or my minor child, or anyone on my and/or my minor child’s behalf, makes a claim against any of the Releases, I WILL INDEMNIFY, SAVE, AND HOLD HARMLESS EACH OF THE RELEASEES from any litigation expenses, attorney fees, loss, liability, damage, or cost which may incur as the result of such claim.

General Tournament Information

Event Entry Fees: See registration form for fees, which vary per event.

Pre-registration Deadline: Thursday, May 25, 7pm. Some late and walk-in registration may be available, but pre-registration is recommended so that your entire family is able to participate.

NOTE: This is an unsanctioned event. No rating points will be awarded. "1500" is the USATT rating level we'll use to determine event eligibility for the U-1500 and O-1500 events, with a cutoff date of 5/1/2017.

Registration Policy: Please read the registration details carefully for each event. Your registration will be considered complete only with the following:

- A legible and fully-completed entry form (include doubles partner name, if doubles is selected)
- Completed liability waivers, including printed name(s) and signature(s)
- Payment in full (check to SSTTPPC or Venmo/PayPal to dave@play3tc.com) as described below

Registration Payments: Full payment must be made at time of registration.

- Mailed registrations - completed entry form may be mailed to Spin & Smash Table Tennis & Ping Pong Club with a check made out to SSTTPPC, or with copy of the Venmo/Paypal receipt issued by SSTTPPC
- In-person registrations - completed entry form may be turned in to Spin & Smash Table Tennis & Ping Pong Club with a check made out to SSTTPPC, a Venmo/Paypal receipt issued by SSTTPPC, or by card. We accept Visa, MC and Amex

Entries are processed in the order received. Full payment & fully completed entry forms are required to process an entry.

Waitlists: If an event is full at the time you register, you will automatically be placed on the waiting list for that event. We'll let you know if a spot becomes available. If a spot does not become available, or you request to be removed from the waitlist, we will refund your fees from the waitlisted event.

Refund Policy:

- ALL entry fees paid become NON-refundable donations to SSTTPPC unless the event is cancelled, or the event is full and the participant is not eligible for any other open events
- **WITHDRAWALS:** Although refunds are not available, please notify Spin & Smash Table Tennis & Ping Pong Club if should you need to withdraw from an event, in case there are other participants waitlisted for it. Please include your name, phone number, and the event from which you wish to be withdrawn
- If an event is cancelled by Spin & Smash Table Tennis & Ping Pong Club for any reason, entry fees may be refunded by SSTTPPC at the option of the participant
- Refunds may take up to two weeks

Reassignment:

- 1) Events with insufficient entries may be cancelled or merged at the discretion of the tournament directors.
- 2) If an event is cancelled, the player will automatically be placed in the next event in which he/she is eligible (e.g., higher age range, or alternate adult entry)

No-Show Policy: Please arrive in time to check in and be ready to play. Events will begin on time, as previously listed. Doors will open by 8am for warm-up and practice. In consideration of all players' time, events will not be delayed for late players. Players who are not present at match start time for an event may forfeit their position and entry fee.

Dress Code: Dress comfortably for a sporting event. Please refrain from wearing white shirts, since table tennis balls are white.

Equipment: Players are encouraged to bring their own paddles. Loaner paddles are available in limited supply. Adult divisions will require USATT-approved paddles and rubber. Tables, balls and nets are Butterfly. Ceiling height is 20 feet with bright, white lighting.

Doubles partners: Players must pre-register with a partner for the doubles event. SSTTPC will not provide doubles partners. It is the responsibility of the participant to contact his/her doubles partner about participating in (and paying for) the event. No refunds will be given if a partner is not available.

Event Format: The initial round for each event will be a round robin of matches within table groups in the event, in which every member of the group has the opportunity to play every other member of that table group. A single winner will advance from each group in the first round. The second round of each event may be, at the discretion of the tournament umpire, either another round robin for winners of the first round, or single elimination for winners of the first round, depending on the time remaining for that event. Fun will reign over USATT rules for this fun grand opening tournament.

If you're taking 270S, we're located just off the Roberts Road exit. Take a left off the exit, then a right onto N. Wilson. If you're taking 270N, take a right off the exit, then a right on N. Wilson Rd. After about 1/4 mile, turn into the Westbrooke Corporate Center across from Mattress Warehouse.

Important Notes:

- Players cannot join an event after the first round. Be early!
