Equipment: 8 Joola 3000-SC tables and nets; good lighting & conditions, A/C. Only approved USATT equipment will be used; 3 star Nittaku Nexcel orange 40+ balls. (An alternative ball agreed on by both players may be used.)

Clothing: Darker colors recommended; no orange shirts; rubber soled shoes only. Exceptions may be made by the referee for special needs.

Rules: All USATT regulations generally apply. The tournament director will have the final judgment on matters of rules and playing eligibility. Ratings Central will be used for seeding and match results will be submitted to Ratings Central. (If you have an USATT rating but no Ratings Central record then the USATT rating will be lowered to the Ratings Central scale by subtracting around 200-250 points.)

Events Format: Limit: 12 teams of 3 or 4 players.

Preliminary round - 4 groups of 3 teams in round robin - **all teams advance** to groups A, B, and C. **Second round** - 3 groups of 4 teams each in round robin. (A, B, C)

<u>Team matches</u> - Best of 5 matches (2 singles, 1 doubles, and if needed, 2 more singles matches). Each player plays 2 matches and no players compete against each other more than once. On each team, one player plays two singles matches and the other players each play one singles and one doubles matches.

Matches will be played 1 or 2 at a time in the following order:

A vs X

B vs Y

C & A or B vs Z & X or Y

(A captain need not name the doubles pair until after completion of the first two singles matches.)

A or B vs Z (A or B that didn't play doubles vs Z)

C vs X or Y (C vs X or Y that didn't play doubles)

Group B - 1st place \$300

Group B - 2nd place \$240

Group C - 1st place \$180

Group C - 2nd place \$120

Event Fees: \$120 / team
