- 2. ACKNOWLEDGE, agree, and represent that I and/or my minor understand the nature of Table Tennis Activities and that I and/or my minor child are qualified, in good health, and in proper physical condition to participate in such Activity. I further agree that if at any time I believe conditions or equipment to be unsafe, I and/or my minor child will immediately discontinue further participation in the Activity.
- 3. ### Qualifying Rating & Seeding

The qualifying rating is used to ensure teams are balanced. The qualifying rating will be used to seed teams. For a three-person team, the qualifying rating is determined by taking the average rating of the three players. For a four-person team, the qualifying rating is calculated by taking the average rating of the three lowest rated players. For a five-person team, the qualifying rating is calculated by taking the average rating of the middle three players.

The maximum spread in rating between a team's highest rated player and the team's overall qualifying rating will be capped:

<u>Qualifying Rating</u>	<u>Maximum Spread</u>
0-1200	500 points
1201-1999	400 points
2000-2199	300 points
2200+:	200 points

\*Please note that the Tournament Committee reserves the right to adjust these limits where necessary. Ratings from December 27th will be used for qualifying rating calculations and ratings from January 24th will be used for seeding

### PLAY FORMAT: Round 1 – Prelims (Saturday):

The prelims matches will be played **One up, One down** – for example:

**One up (for Division B)** Division B plays Division A, winner remains in Division A, loser continues to play **One Down** preliminaries.

**One down (for Division B)** – Division B plays Division C, winner stays at Division B

**Round 2 (Saturday & Sunday):** Groups are now in the appropriate Divisions and will be 1 group of 8 RR. Placements will be decided by team records.

## General Tournament Information

**EVENT ENTRY FEES:** See registration form for fees, which vary by event.

### Registration Policy:

All registrations must be properly and completely submitted. Please read the registration details carefully for each event. Your registration will be considered incomplete and will not be processed if any of the following is missing:

- A legible and fully-completed entry form
- Completed waivers, including printed names and signatures for ALL waivers
- Payment in full for ALL registered events, plus USATT membership or renewal fee (if needed), plus late fee (if applicable)
- A current USATT membership number or membership registration form

**Full payment & fully completed entry forms are required to process an entry.**

### Registration Payments:

**Full payment must be made at the time of registration.** Accounts will be charged a \$25 fee for returned checks. Participants with declined payment will be withdrawn from the tournament.

There are multiple ways to register for this tournament. Please either:

- Complete a printed entry form, sign the waivers, and pay at the front desk by cash, check, or credit card.
- Complete the entry on-line at [Omnipong.com](http://Omnipong.com), or
- Complete a printed entry form, sign the waivers, and mail it to Triangle Badminton and Table Tennis, 2900 Perimeter Park Drive, Suite 200, Morrisville NC 27560 with a personal check (or cashiers/registered/bank check) made payable in US dollars to Triangle Badminton and Table Tennis.

**Prizes and Tax Information:** Prizes may include cash, account credit, pro shop merchandise, and/or medals. All cash prizes are in the form of checks. Players must complete Form W-9 and provide taxpayer ID (e.g., social security number) to receive prizes with

monetary values. If a winner cannot fill out a W-9 form due to being a foreign national and not having a US tax ID number, then they must accurately complete a W-8BEN tax form. The prize winnings of players required to fill out the W-8BEN tax form are subject to 30% tax withholding and the prize winnings will be withheld until such time that the tournament administrators have time to process the appropriate prize amounts. Foreign national players will need to provide a valid current address to receive their tax-adjusted prizes by mail.

**Event Limitations:**

**This tournament has a limited number of players or teams allowed for each event.** Complete entries with payment are processed in the order received. Once an event is full (based on a target number set at the discretion of the Tournament Director), that event will be closed and no further entries accepted. Entering early will give you a better chance of getting into an event before it is full.

**Waitlists:**

**If an event is full at the time you register, then you will be automatically put on that event's waitlist.** You will be informed if you are waitlisted. You will be notified if a spot becomes available. If a spot does not become available or you request to be removed from the waitlist, the registration fees for the waitlisted event will be refunded to you.

**Refund Policy:**

- \$200 NON REFUNDABLE upon payment/registration. The remaining balance of the registration fee will be refunded in full before July 15<sup>th</sup>. From January 15<sup>th</sup> onward, there will be no refunds.
- Events may be cancelled for insufficient entries, or other reasons, at the discretion of the Tournament Director.
- If an event is cancelled by Triangle Badminton and Table Tennis, or the Tournament Director, for any reason, then entry fees will be refunded. Refunds may take up to four weeks.
- **Withdrawals & Refunds:** Entry fees which are refundable (i.e., prior to seven days before the tournament), will be refunded. In order to claim this, a **written withdrawal request** MUST be submitted by the player for Triangle Badminton and Table Tennis to consider a refund. Please include your name, phone number, and the events you wish to be withdrawn from. All entry fees are NON-REFUNDABLE after January 4th.

**No-Show Policy:** Players who are not present at match start time for any event forfeit their position and entry fees for that event.

**Dress Code:** USATT Dress Code will be enforced in all cases as determined by the Tournament Referee.

**Rules:** All USATT Regulations apply, and all participants must abide by the decisions of the tournament staff and officials. Triangle Badminton and Table Tennis Club Rules will also be enforced; violators may be asked to leave. If ejected due to violation of Club rules, the player will be defaulted automatically and no fee refunds will be issued. Players that default a match or matches for non-health related reasons may not be eligible for prizes and will also be at risk for future entry into Triangle Badminton and Table Tennis tournaments.

**Equipment:** All USATT Regulations Apply. Only USATT/ITTF approved equipment will be used. Tables will be Butterfly Centrefold 25 blue color with Butterfly Europa net sets. Floors are all covered with Gerflor (Taraflex) flooring. Balls will be Butterfly 3-star white R40+ premium competition poly balls.

**USATT Membership:** Players must have a currently active USATT membership to play in USATT sanctioned events. Players without a currently active membership at the time of registration must include their USATT registration or renewal fees along with their tournament event fees when submitting payment. Please see USATT membership page for more details on membership options and rates.

**Required USATT Statements:**

- 1) Events with insufficient entries may be cancelled at the discretion of Triangle Badminton and Table Tennis. Fees managed as outlined in the refund policy.
- 2) If a rating event is cancelled, player will automatically be placed in the next highest rating event (only if applicable based on tournament format). Not applicable in teams tournaments.

- 3) The current USATT rating system will be used for the purposes of conducting all draws with the possible exception of hardbat events, if offered. For players that do not have a USATT rating, an estimated USATT rating will be assigned based upon a recommendation by a coach who knows the player or by visual evaluation of the player by a coach, whenever possible.
