I further agree that if at any time I believe conditions or equipment to be unsafe, I and/or my minor child will immediately discontinue further participation in the Activity
- 3. FULLY UNDERSTAND that (a) TABLE TENNISACTIVITIES INVOLVERISKS AND DANGERS OF SERIOUS BODILY INJURY INCLUDING PERMANENT DISABILITY. ENTRY DEADLINE: All entries must be received no later than October 16 at 5:00 pm. Late entries may be accepted only at the discretion of the Tournament Director. Please Note: Events are known for filling up early and closing. Once an event has closed, you may opt to get on a waitlist, but there is a good chance you will not be able to get into that event. To ensure that you get into the events that you want, please **ENTER EARLY!**

EVENT LIMITATIONS: Players may not enter events with conflicting times. Most rating events require approximately 3 hours to complete, so players may not enter events that start less than 2.5-3 hours apart.

USATT SANCTION: This tournament has a USATT 4-Star Sanction Level.

A USATT membership or Single Tournament Pass is required for entry into rated events, and results from those events will be sent to USATT for inclusion in USATT player ratings calculations.

Registration Payments:

Full payment must be made at the time of registration. Accounts will be charged a \$25 fee for returned checks. Participants with declined payment will be withdrawn from the tournament.

There are multiple ways to register for this tournament. Please either:

- Complete a printed entry form, sign the waivers, and pay at the front desk by cash, check, or credit card.
- Complete a printed entry form, sign the waivers, and mail it to Triangle Badminton and Table Tennis, 2900 Perimeter Park
 Drive, Suite 200, Morrisville NC 27560 with a personal check (or cashiers/registered/bank check) made payable in US
 dollars to Triangle Badminton and Table Tennis.

Prizes and Tax Information: Prizes may include cash, gift cards, pro shop merchandise, trophies, and/or medals. All cash prizes are in the form of checks. Players must complete Form W-9 and provide taxpayer ID (e.g., social security number) to receive prizes with monetary values. If a winner cannot fill out a W-9 form due to being a foreign national and not having a US tax ID number, then they must accurately complete a W-8BEN tax form. The prize winnings of players required to fill out the W-8BEN tax form are subject to 30% tax withholding and the prize winnings will be withheld until such time that the tournament administrators have time to process the appropriate prize amounts. Foreign national players will need to provide a valid current address in order to receive their tax-adjusted prizes by mail.

Event Limitations:

This tournament has a limited number of players or teams allowed for each event. Complete entries with payment are processed in the order received. Once an event is full (based on a target number set at the discretion of the Tournament Director), that event will be closed and no further entries accepted. Entering early will give you a better chance of getting into an event before it is full. TBTT reserves the right to cancel events and/or reduce prize offerings due to low enrollment. TBTT will evaluate this based upon enrollments received to date on March 27, 2021.

Waitlists:

If an event is full at the time you register, then you will be automatically put on that event's waitlist once payment is received. You will be informed if you are waitlisted. You will be notified if a spot becomes available. If a spot does not become available or you request to be removed from the waitlist, the registration fees for the waitlisted event will be refunded to you.

Refund Policy:

- >> ALL entry fees paid are NON-REFUNDABLE one week prior to the start of the tournament. For instance, if the tournament starts on a Saturday, then entry fees are non-refundable starting on the previous Saturday. In this case, refunds would have to be submitted by the close of business on the previous Friday.
- > Events may be cancelled for insufficient entries, or other reasons, at the discretion of the Tournament Director.
- > If an event is cancelled by Triangle Badminton and Table Tennis, or the Tournament Director, <u>for any reason</u>, then entry fees will be refunded. Refunds may take up to four weeks.
- Withdrawals & Refunds: Entry fees which are refundable (i.e., prior to seven days <u>before</u> the tournament), will be refunded ONLY as a Triangle Badminton and Table Tennis account credit. In order to claim this, a <u>written withdrawal</u> request MUST be submitted by the player for Triangle Badminton and Table Tennis to consider a refund. Please include your name, phone number, and the events you wish to be withdrawn from. All entry fees are NON-REFUNDABLE after 7 days prior to tournament date. An administrative fee of \$10 will be deducted from all refunds.

No-Show Policy: Players who are not present at match start time for any event forfeit their position and entry fees for that event.

Dress Code: USATT Dress Code will be enforced in all cases as determined by the Tournament Referee.

Center Rules: Triangle Badminton and Table Tennis Center rules will be enforced; violators may be asked to leave. If ejected due to violation of Center rules, the player will be defaulted automatically and no fee refunds will be issued.

Equipment: All USATT Regulations Apply. Only USATT/ITTF approved equipment will be used. Tables and nets will be Butterfly. Floors are all covered with Gerflor (Taraflex) flooring. Balls will be white Butterfly R40+ 3star.

USATT Ratings: Ratings as posted on USATT website approximately one week before tournament are used for USATT-rated events.

USATT Membership: Players must have a currently active USATT membership to play in USATT sanctioned events. Players without a currently active membership at the time of registration must include their USATT registration or renewal fees along with their tournament event fees when submitting payment. Please see USATT membership page (last page) for more details on membership options and rates. Some events do not require USATT membership and will be identified as such on the entry form.

Required USATT Statements:

- 1) Events with insufficient entries may be cancelled at the discretion of Triangle Badminton and Table Tennis. Fees managed as outlined in the refund policy.
- 2) If a rating event is cancelled, player will automatically be placed in the next highest rating event (only if applicable based on tournament format). Not applicable in teams tournaments.
- 3) The current USATT rating system will be used for the purposes of conducting all draws with the possible exception of hardbat events, if offered. For players that do not have a USATT rating, an estimated USATT rating will be assigned based upon a recommendation by a coach who knows the player or by visual evaluation of the player by a coach, whenever possible.
