ENTRANT REQUIREMENTS: Must be current member of the USATT, or affiliated ITTF member. A USATT membership includes a sanctioned tournament rating; it can be purchased through the tournament entry form. We will use the current USATT rating system to conduct all draws. UNRATED PLAYERS cannot play in rated doubles events or advance out of rated round-robin events; rated players with the best record will advance.

ENTRY DEADLINE: All entries must be received by **Aug. 11th, 2018**. Late entries, phone entries and walk-ins will only be accepted if space is available and at the director's discretion.

REGULATIONS: All USATT regulations apply and USATT approved equipment are to be used. Please refer to the USATT dress code guidelines for clothing/attire.

VENUE/EQUIPMENT: 8 Donic Waldner Premium 30 tables with Donic Stress nets, Nittaku 3-Star Premium 40 mm Plastic 40+ balls made in Japan (white), 8 Donic Waldner Premium 30 tables with Donic Stress nets, ITTF-approved red sports flooring and LED lighting

CONDUCT: Follow the sequence of play on the score sheet so you will be aware when you are next up. Please keep your warm-ups limited to two minutes and write down the scores after each game. Following the completion of a RR or a SE match, bring the completed scoresheet to the control desk.

FOOD/PARKING: Paddle Palace Club is located in downtown Tigard on Main Street, 20 minutes from downtown Portland. The venue offers several restaurants within walking distance and free parking.

ENTRY: Entrants may enter multiple events. Events with insufficient entries may be cancelled with entrance fees fully refunded.

FORMAT: Round Robin round then single-elimination round. All matches are 3 out of 5.

EVENT REPORTING: Please report 30 minutes minimum prior to your event.
