Professional facility - 22' ceiling, Enlio rubber floor, white Butterfly R40+ balls, blue Butterfly Europa tables, lounge, breakroom, lockers Format - Round robin events with 4 or more players per group with 2 advancing from each group to single elimination (SE). Giant RR advances 4 to SE. All matches best 3 out of 5, except for Open finals, which will be 4 out of 7. *In Draw doubles we take the top half the players into one pool and the bottom half into the second pool and do a blind draw to form the teams. We reserve the right to change formats as necessary. Rules - All USATT regulations apply; only USATT approved equipment; USATT dress code will be enforced - no white clothing. Players cannot enter 2 events with the same starting time.

<u>Payments</u> - Withdrawals through Monday, January 31 will receive a refund. No refunds after November 29. All payments must be received by midnight January 31. Late entries may be accepted until February 3 with a \$5 late fee based on availability. No phone entries.

All entries must be paid prior to participation. Unpaid registrations will be removed Tuesday, February 1.

<u>Food/Hotel</u> - The playing venue is near several fast food and other restaurants; Courtyard by Marriott Columbus West (614) 771-8999.

<u>Ratings</u> - Ratings from January 15 will be used for eligibility. Updated ratings will be used for seeding. Tournament staff may modify, combine, cancel events and limit total entrants. Unrated players may enter any event but cannot advance from rated events; they can advance from the Open and the Open Doubles RR and receive prizes.
