Qualification – Round-Robin Groups: If there are fewer than 16 players, no qualification stage will be held. A knockout round draw may be conducted after the completion of the round-robin stage to determine the 12 players who will advance to Stage 2. The exact playing system may vary slightly between age groups, depending on the number of entries. A detailed playing system will be announced after the entry deadline. Modified Snake Draw will be used Stage 2 – Round-Robin / Placement 12 players are divided into two round-robin groups using a modified snake draw based on group finishing order not by player rating If two players already played in Qualification, the lower-seeded player is placed in the other group. Top 4 players advanced Final Stage – Stage 3 Top 4 finishers from each Stage 2 group play round robin against the top 4 from the other group (carry-over results applied). Players finishing 5th–6th in each group also play cross-over matches for placement Consolation Draw will be played for those who place 2nd in qualification group and do not advance to second stage.	All players must show proof of USATT Pro Membership at the time of registration. Renewals will be sold at the event. All Registration will be conducted through WWW.OMNIPONG.COM All matches will count towards USATT Rating and USATT Ranking and for US National Team Ranking. Deadline for registration: April 1, 2026	Only players who are a US Citizen and can represent the US at the 2026 Pan Am Youth Championships and 2026 World Youth Championships according to the ITTF eligibility rules, can compete at the 2026 US Junior Ranking Tournaments	I understand USATT's Safe Sport Policy including the organization's Coaching Policy, which requires that all persons who are engaged in coaching activities at USATT Affiliated Member Clubs and/or USATT Sanctioned Tournaments, except parents or legal guardians coaching their own children, must be fully Safe Sport Compliant, which includes completing SafeSport Training offered by the US Center for SafeSport every year and undergoing a criminal background screen every two years.	
For U17 Boys and Girls system of play will be Round Robin with top players advancing to Single Elimination	Entries will be accepted only if they include entry fee, signed waiver and proof of citizenship. All participants must bring passport copy at the event. Late entries can be accepted if there is spots left in the draw but will be subject to \$100 late fee per event.	Only USATT members in good standing may participate. Players need to be current USATT Pro or Gold Members . Signed USATT National Team Code of Conduct forms and Waiver will be required by all participants. Players will be required to upload their proof of citizenship in Just Go Platform following instructions here. Please note: If a player has already registered with the ITTF or played National Team Trials for another country, such player is not eligible to enter this tournament.
