If there are 9 or more entries the event will be played in Round Robin with top players advancing to the play off phase. The playing system can be adjusted based on the number of players entered. A detailed playing system will be communicated after the entry deadline.	All players must show proof of USATT Pro Membership at the time of registration. Renewals will be sold at the event. All Registration will be conducted through www.OmniPong.com All matches will count towards USATT Rating and USATT Ranking and for US National Team Ranking. Deadline for registration: July 12, 2026 Late entries can be accepted if there are still spots in the draw but are subject to \$100 late fee. Entries will be accepted only if they include entry fee, signed waiver and proof of citizenship	Only players who are a US Citizen and can represent the US at the 2026 ITTF Pan American Championships according to the IOC and ITTF eligibility rules, can compete at the 2026 US Adult Ranking Tournaments Only USATT members in good standing may participate. Players need to be current USATT Pro Members. Signed USATT National Team Code of Conduct forms and Waiver will be required by all participants. Players will be required to provide a copy of their current passport or birth certificate to prove eligibility. Please note: If a player has already registered with the ITTF or played National Team Trials for another country, such player is not eligible to enter this tournament.	I understand USATT's Safe Sport Policy including the organization's Coaching Policy, which requires that all persons who are engaged in coaching activities at USATT Affiliated Member Clubs and/or USATT Sanctioned Tournaments, except parents or legal guardians coaching their own children, must be fully Safe Sport Compliant, which includes completing SafeSport Training offered by the US Center for SafeSport every year and undergoing a criminal background screen every two years.
