Training Camp Info-

Friday, Feb 14 (4- 6pm & 7-9pm) & **Saturday, Feb 14** (10am-12:30pm & 1:30-4pm)

Eligibility- Players must be born on or after 1/1/2008. *Anyone under the age of 15 may register for the training camp but cannot play in the Hopes qualification tournament – subject to availability. However, priority will be given to those born on or after 1/1/2008.*

Participants will receive expert coaching and training by the hosting Club local coach(es) in a fun, educational, rewarding environment in which they will meet, learn, and share experiences. A U.S. Olympian will participate in the camp and share his/her athlete experience with participants. *Coaching ratio: 1 coach / 10 students.*

Eligibility- Players must be born on or after 1/1/2008; be a U.S. citizen, be a member of USATT in good standing and must participate in the two-day camp

Events- Hopes Boys' and Girls singles

Playing format-

This is a USATT sanctioned tournament. Round-robin first stage with top two advancing from each group to a single-elimination knock out with cross over matches to determine the winner and runner up, also 3rd and 4th place. All matches are best 3 out of 5. *The tournament committee reserves the right to modify the*

format according to the number of entries and reserves the right of acceptance or refusal of all tournament entries.

Ratings- The latest USATT rating published will be used for tournament seeding and draw purpose

KIDS FUN Tournament Format:

Open to any kids under the age of 15. Format: 4-palyer round robin groups with the top 2 players advancing to a single elimination knock out with crossover matches to determine final prize awards for the 1-4 places. All matches are 3 out of 5.
