#### PLEASE READ THOROUGHLY AND PROVIDE YOUR SIGNATURE

IN CONSIDERATION of being permitted to participate in any way in USA Table Tennis sanctioned events, I and/or minor child, our personal representatives, assigns, heirs, and next of kin:

ACKNOWLEDGE, agree, and represent that I and/or minor-aged child understand and assume the nature and risks of Table Tennis Activities, including but not limited to risks involved in the sport itself together with all risks, known and unknown, associated with gatherings of people ("Activities"), including the exposure to COVID-19, coronavirus, or other infectious organisms or diseases; and that I and/or minor child are qualified, in good health, and in proper physical condition to participate in such Activities. I further agree that if at any time I believe conditions or equipment to be unsafe, I and/ or minor child will immediately discontinue further participation in the Activities.

FULLY UNDERSTAND that (a) TABLE TENNIS ACTIVITIES INVOLVE RISKS AND DANGERS OF SERIOUS BODILY INJURY, INCLUDING PERMANENT DISABILITY, PARALYSIS, DISMEMBERMENT, AND DEATH ("RISKS"); (b) these Risks and dangers may be caused by me and/or minor child's own actions, or inaction, or the actions or inaction of others participating in the Activities, the condition in which the Activities takes place, or THE NEGLIGENCE OF THE "RELEASEES" NAMED BELOW; (c) there may be OTHER RISKS AND SEVERE SOCIAL AND ECONOMIC LOSSES either not known to me or not readily foreseeable at this time; and I FULLY ACCEPT AND ASSUME ALL SUCH RISKS AND ALL RESPONSIBILITY FOR LOSSES, COSTS, AND DAMAGES I and/or minor child incur as a result of my participation in such Activities.

HEREBY ACCEPT AND ASSUME ALL SUCH RISKS, KNOWN AND UNKNOWN, AND ASSUME ALL RESPONSIBILITY FOR THE LOSSES, COSTS, AND/ OR DAMAGES FOLLOWING SUCH INJURY, DISABILITY, PARALYSIS, OR DEATH, EVEN IF CAUSED, IN WHOLE OR IN PART, BY THE NEGLIGENCE OF THE "RELEASEES" NAMED BELOW.

HEREBY RELEASE, DISCHARGE, AND COVENANT NOT TO SUE USA TABLE TENNIS, their respective administrators, directors, agents, officers, officials, volunteers, and employees, other participants, any sponsors, advertisers, and if applicable, owners and lessors of premises on which the Activities takes place, (each considered one of the "RELEASEES" herein) FROM ALL LIABILITY, CLAIMS, DEMANDS, LOSSES, OR DAMAGES ON MY ACCOUNT CAUSED OR ALLEGED TO BE CAUSED IN WHOLE OR IN PART BY THE NEGLIGENCE OF THE "RELEASEES" OR OTHERWISE, INCLUDING NEGLIGENT RESCUE OPERATIONS; AND I FURTHER AGREE that if, despite this RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK, AND INDEMNITY AGREEMENT I and/or my minor child, or anyone on my and/or my minor child's behalf, makes a claim against any of the Releases, I WILL INDEMNIFY, SAVE, AND HOLD HARMLESS EACH OF THE RELEASEES from any litigation expenses, attorney fees, loss, liability, damage, or cost which may incur as the result of such claim.

I swear and affirm that I am in good physical condition and I am not aware of any previous or existing diseases or injury that would result in my being injured. I further acknowledge that I have procured on my own and currently hold valid and adequate insurance for such loss, damage, or injury and if I do not have valid and adequate insurance, I accept full responsibility for the cost of the loss, damage, or injury that might occur as a result of my participation in the 2021 US Open Table Tennis Championships. I give my consent to participate in any and all emergency transportation associated with activities during the 2021 US Open Table Tennis Championships, in the event I become incapacitated or otherwise not conscious to give direct consent and I accept full responsibility for all costs associated with all emergency transportation as deemed necessary. Further, as the parent/guardian of a participating minor athlete, I hereby give my consent for complete medical treatment and emergency transportation services as deemed necessary beyond the on-site athletic trainer or emergency medical treatment provided.

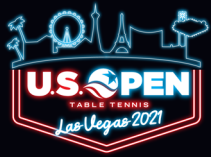

**Rules:** The 2021 U.S. Open Table Tennis Championships will be conducted under the ITTF Rules.

**Call for Umpires:** USATT is asking players who are umpires to volunteer to umpire at the US Open Table Tennis Championships. The umpire must be available for a block of four hours or more. Please contact: Roman Tinyszin (iuroman@comcast.net).

**Membership:** USATT Memberships must be valid through December 22, 2021. Non-members or expired memberships must enclose membership fee with their entry forms or purchase a one-time Tournament Pass for \$50.

**Matches:** All matches will be best three out of five games to eleven, unless otherwise specified.

**Event Scheduling:** Events are not guaranteed to be completed on the same day that they begin. **No refunds will be given for early departure.** All events will be completed by Wednesday, December 22, 2021, evening. Any event may be cancelled if the event contains less than four players or pairs, as appropriate. (For Event Fee Participants, the cost of an event cancelled for lack of appropriate numbers of participants will be refunded.) In the case of event conflicts, the player is responsible for notifying the Control Desk as soon as possible. In case of an inadvertent error, liability is limited to the refund of the event fee for the event(s) involved. For Team Age Events, all players on the team must qualify on the age restrictions for the team event. Proof of age must be readily available at the tournament. ## Rating Events

**Rating Restrictions and Seeding:** For rating eligibility (qualification), the ratings list as of 10/17/2021 will be used. This can be found on the rating page at www.USATT.org or by email to Tina.Ren@usatt.org. For draw and seeding purposes, the most recent USATT rating list as of 12/01/2021 will be used. Players that are over the rating limit of an event will automatically be entered in the next event. Players may obtain their ratings by contacting USA Table Tennis via email at Tina.Ren@usatt.org. As a result of later seeding, some players may have ratings higher than shown for the event.

**Unrated Players: players without USATT rating:** Players may enter any championship event for which they are otherwise eligible. Players who are unrated on the seeding date (December 2, 2021) will not advance to the single elimination stage of rating-restricted RR events. Players who enter a rating-restricted event without a rating and who acquire a rating between the qualification cutoff (10/17/2021) and the seeding (12/01/2021) will be permitted to advance provided their new rating meets the event's requirements. Unrated players are not permitted to enter rating-restricted single elimination events.

**RATING DOUBLES EVENTS:** Players MUST be rated under 2600 to participate in the U4500 Doubles; under 2300 to participate in U3800 Doubles; and under 2100 to participate in the U3100 Doubles.

**Rating Adult and Junior Events:** Players entering the Rating Junior events must be born on or after 1/1/2003 (18 and under). Players entering the Rating Adult events must be born on or before 12/31/2002 (19 and over).

## PLAYING FORMATS:

**Preliminary Rounds will be Round Robin Format:** Unless otherwise announced prior to the start of the event, all preliminary rounds will be round robin format, leading to a single elimination event bracket. The Competition Manager reserves the right to directly seed players into the single elimination event bracket draw based on USATT Ratings. The Competition Manager's decision in this regard is final.

**Men's and Women's Singles Championship Events:** All matches in the main draw and qualification will be 4 out of 7 games.

**U - 21 Men's and Women's Singles:** Matches will be 3 out of 5 games in qualification rounds, and 4 out of 7 games in the main draw.

**Men's, Women's and Mixed Doubles:** Matches will be 3 out of 5 games in qualification rounds, and 4 out of 7 games in the main draw.

**Teams:** Corbillon Cup System: 4 singles and 1 doubles. A-X, B-Y, doubles, A-Y, B-X Playing system will be Single Elimination or Round Robin depending on number of entries. There can be a maximum of three members on each team.

**Doubles Partners:** Players MUST enter with a partner in all doubles events. USA Table Tennis will NOT arrange for a doubles partner. USATT cannot be responsible for the nonparticipation of your selected Doubles Partner. It is the responsibility of the players to contact his/her doubles partner about participating in the event. Players without a rating at the Qualification time can't enter rating doubles events. Partners withdrawing before December 1, 2021, may be replaced provided the replacement partner has a lower rating than the original partner, partners withdrawing after December 1, 2021, may not be replaced. If you have not found a doubles partner as of December 1, 2021, you will be dropped from the event.

**Hardbat Event:** This event will follow the hardbat rules adopted by the USATT Classic Table Tennis Committee found at www.hardbat.com. Rackets must comply with the rules found on www.hardbat.com. This event will not count for USATT rating points. Seeding will be based on hardbat ratings, or USATT ratings for players who do not have hardbat ratings. Matches will be best 2 out of 3 games to 21 except for the quarterfinals, semifinals and finals, which will be best 3 out of 5 games. Ball: Nittaku Premium 40+, White.

**Sandpaper Event:** This event will follow the hardbat rules, except that rackets must be wooden blades with sandpaper playing surfaces. Matches will be best 2 out of 3 games to 21 except for the quarterfinals, semifinals and finals, which will be best 3 out of 5 games. Ball: Nittaku 38mm, Orange.

**Para Events:** Adult Para Events are open to all para athletes. To participate in Youth Para Events, the participant must be born on or after January 1, 2003 (18 and Under). ## WORLD UNIVERSITY GAMES TRIALS - Presented by NCTTA

Description: The World University Games are taking place June 26 - July 7, 2022. The US team consists of 5 men and 5 women. Eligible Participants must be:

(i) a US Citizen; (ii) at least 18 years old and no older than 26 years old on December 31, 2022, (i.e. born between 1 January 1996 and 31 December 2004) (iii) currently officially registered as proceeding towards a degree or diploma at his/her university or similar institute, the status of which is recognized by the appropriate national/regional academic authority of their country/region OR Former students of eligible institutions who have obtained their academic degree or diploma in the calendar year preceding the event

NOTE: The University must be a current NCTTA member. There are limited memberships available for athletes whose schools are not current members.

There is no rating criteria to compete in the Trials. Competing in the Trials does not commit you to playing for the United States team, but the results will be used to select the Team. Full selection procedures and more information can be found here.
