Eligibility

USATT clubs from the following states may enter teams: Connecticut, Massachusetts, Maine, New Hampshire, New Jersey, New York, Pennsylvania, Rhode Island, and Vermont.

Prizes

- 1st: \$1,200 + engraved crystal
- 2nd: \$600 + engraved crystal
- 3rd: \$300
- 4th: \$150

In addition, the winning team will receive free entry to the Team Event at the U.S. Nationals in July, with \$12,000 in prizes. Teams coming in second and third will also be invited to participate in the Team Event at Nationals.

Format

Play will follow the Olympic system (ABC vs. XYZ) as

follows: Match 1 (doubles) – B + C vs. Y + Z • Match 2 – A vs. X • Match 3 – C vs. Y • Match 4 (if needed) – A vs. Y • Match 5 (if needed) – B vs. X. • All events are round robin format followed by single elimination playoffs. Two teams will advance from each round robin group. • Starting time: 9:00 a.m.
