Deadline for registration: Jul 20, 2025 Entries will be accepted only if they include entry fee, signed waiver and proof of citizenship	Only players who are a US Citizen and can represent the US at the 2025 ITTF Pan American Championships according to the IOC and ITTF eligibility rules, can compete at the 2025 US Adult Ranking Tournaments Only USATT members in good standing may participate. Players need to be current USATT Pro Members . Signed USATT National Team Code of Conduct forms and Waiver will be required by all participants. Players will be required to provide a copy of their current passport or birth certificate to prove eligibility. Please note: If a player has already registered with the ITTF or played National Team Trials for another country, such player is not eligible to enter this tournament.
