Format: Teams may consist of 2 or 3 players. Teams will be seeded into preliminary RR groups of 4 teams. Seeding will be based upon the top two players of a team. Winners of preliminary RR play will be placed into Division A, second place teams will go into Division B, third place into Division C, and fourth place into Division D. Divisions will also be RR groups. A team match is played with two players on each team and will be best of five individual matches, A v. X, B v. Y, Doubles (A&B v. X&Y), A v. Y, and B v. X. An individual match will be best of 5 games.

Note: No more than 20 teams will be accepted. So, get your entry in early! **Each player on a team must submit a completed registration form and pay the \$10 tournament processing fee and USATT membership if necessary.** Singles match results will be submitted for ratings. The team entry fee is \$160.

- The latest USATT ratings will be used for seeding.
- USATT membership or tournament pass is required (see below). Players must be able to show proof of USATT membership.
- All USATT regulations and rules apply including dress code.
- Equipment will be 10 DHS tables; white Nittaku Premium 40+ balls; and wood gym floor. Only USATT approved equipment may be used.
- Tournament staff reserves the right to modify events, formats, group assignments, etc. as necessary.
- Players must check-in at least 30 minutes prior to event start time. Default time is start time.
- Entries are first come/first serve. **Entries must be received by Monday, September 11, 2023.** No refunds after entry deadline.
- Unrated players will be given estimated ratings for seeding purposes. .
- Coaches must follow USATT SafeSport policies or will not be allowed to coach. See back of entry form.
