**IMPORTANT: Payment must be received to confirm the events.** Only paid entries as of the entry deadline considered as entered and placed into the draws.

**Refunds: No refunds after October 26, 2019 unless the tournament is cancelled.** Refunds given for events cancelled by the tournament management.

**Entry deadline is October 26, 2019.** Late entries may be accepted at the tournament director's discretion, space permitting with \$10 late entry fee.

**Format:** All matches are 3 out of 5 games to 11 points except for U10, U14 and Open Doubles RR (2 out of 3 games to 11 points). Final of the Open Singles is 4 out of 7 games to 11 points.

**Policies:** All USATT regulations apply including dress code. No prizes awarded for splits, dumps, defaults, or no-shows. Events may be modified at the discretion of the Tournament Director. Do not enter 2 events with same starting time. USATT approved tiebreaking procedures will be used. No white shirts, shorts, or skirts. Must be present for match start times, with 5 minutes provided before defaulting.

Any image, photographic or otherwise, taken of the tournament play or within the official venue is the property of USATT. Entrants agree to allow their picture, voice and likeness to be reproduced in connection with USATT by way of any medium.

**Proof of USATT Membership:** Must show the proof of USATT membership or USATT tournament pass for the **Event 1-12**. USATT memberships, renewals and tournament passes sold at the tournament. All players must either be current USATT members or purchase a USATT tournament pass for \$20.

**USATT Membership fees:** Adults \$75/year; Juniors/Collegiate \$45/year. **USATT One-Time Tournament Pass:** \$20

**Optional Donation to the Table Tennis Team USA National Program:** Participants in the tournament can voluntarily add an amount of your choosing to donate to the national table tennis program.
