Venue: Englewood Recreation Center, 1155 W Oxford Ave, Englewood, CO 80110

Dates: 2/14/2026 – 2/16/2026 (hall will be open every day at 8am)

Organizing clubs: Denver Table Tennis Alliance (USATT ID CL000309) and Mile High Table Tennis Academy (USATT ID CL000466)

Equipment: 8 Butterfly Tables Centerfold 25 and 6 Joola World Cup 25-S, Butterfly and Joola Nets, Butterfly and Joola Barriers, and white Joola Prime 40+ 3-star Balls. The floor is a wooden sports floor.

Rules: Players must be members of the USATT or other ITTF affiliate associations. The Laws of Table Tennis as published by the ITTF, and all USATT regulations apply. The USATT dress code will be observed. All matches will be best of 5 games to 11 points, except for the final of the Open, which will be best of 7.

Proof of membership: Every participant must show proof of USATT membership for all events. Membership and renewals will be sold at the event or can be updated in your personal membership account on the JustGo platform prior to entering the tournament. You have the following options; Tournament pass \$20 / 1yr Silver \$50, 1 yr Gold \$100. Every player has to pay \$3 usatt rating fee when entering for the tournament and \$5 registration fee. The registration fee will be waived if payment for the entry fee has been received by February 4th the latest.

Policies: The maximum number of players in most of the single events is twenty-eight (28), except for the U1150 (16), the U21jr (20), the O40 (20) and the Open Singles (32), both doubles events will have a maximum number of pairs of eighteen (18). Events with insufficient entries may be canceled, and fees refunded. Unrated players will not be allowed to advance out of groups, except in the Open Singles, Open Doubles, O40jr and U21jr and U800. The Tournament Director may assign an estimated rating to an unrated player. You can only enter one event at the same time.

Prize money: In total there will be prize money of \$6,230 awarded in cash and \$720 in gift certificates.

Payment: Payments must be received prior to the start of the tournament, by Zelle (milehightta@gmail.com), by cash or by check (payable to Mile High Table Tennis Academy)

and will not be accepted at the tournament. Payment for the registration must be made within three days of your entry, otherwise you may be removed to free up a slot for another player.

Entry Deadline: Only online entry will be available through www.omnipong.com, the latest by Monday, February 9th, 2026. Late entries may be accepted at the discretion of the tournament committee if the event is not full. Late fee of \$15 will apply.

Registration: Players must register with tournament officials at least 30 minutes before their first match and be ready to play each match 10 minutes before the scheduled starting time.

Withdrawal: Any player who wishes to withdraw from the event must do so the latest by Monday, February 9th, 2025. There will be no refunds after this date.

Ratings: Your rating on January 17th will be used for event qualifying. Seedings will be based on the most current rating available.

Playing System on Saturday and Sunday:

Round Robin groups will as much as possible consist of 4 players with two players advancing to the single elimination draw.

Playing System on Monday:

Players will be seeded based on USATT Tournament rating. Top 8 players will be Division A, 9th through 16th seeded players go to Division B and so on.

Preliminary round on Monday at 9 am format: One up, One down – for example: One up (for Division B) Division B plays Division A, winner remains in Division A, loser continues to play One Down preliminaries. One down (for Division B) – Division B plays Division C, winner stays at Division B One down may be played first or vice-versa. After the Divisions are finalized, a Giant RR will be played among the players within the Division

No prizes will be awarded for splits, dumps, default losses or no-shows.

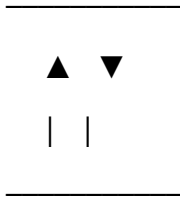
Children under 18 need to be accompanied by an adult/guardian or make alternate arrangements with TD. Tournaments can end early.

- One Up **or** One Down may be played first

- Once a player moves **up or down**, they are placed
- After preliminaries, **no more division movement**

ACKNOWLEDGE, agree, and represent that I and/or my minor understand the nature of Table Tennis Activities and that I and/or my minor child are qualified, in good health, and in proper physical condition to participate in such Activity. I further agree that if at any time I believe conditions or equipment to be unsafe, I and/or my minor child will immediately discontinue further participation in the Activity.

3. FULLY UNDERSTAND that (a) TABLE TENNIS ACTIVITIES INVOLVE RISKS AND DANGERS OF SERIOUS BODILY

INJURY, INCLUDING PERMANENT DISABILITY, PARALYSIS AND DEATH, HARASSMENT, EXPOSURE TO INAPPROPRIATE CONDUCT AND LANGUAGE ("RISKS"); (b) these Risks and dangers may be caused by me and/or my child's own actions, or inaction, or the actions or inaction of others participating in the Activity, the condition in which the Activity takes place, or THE NEGLIGENCE OF THE "RELEASEES" NAMED BELOW; (c) there may be OTHER RISKS AND SEVERE SOCIAL AND ECONOMIC LOSSES either not known to me or not readily foreseeable at this time; and I FULLY ACCEPT AND ASSUME ALL SUCH RISKS AND ALL RESPONSIBILITY FOR LOSSES, COSTS, AND DAMAGES I and/or my minor child incur as a result of my participation in the Activity.

4. HEREBY ACCEPT AND ASSUME ALL SUCH RISKS, KNOWN AND UNKNOWN, AND ASSUME ALL RESPONSIBILITY FOR THE LOSSES, COSTS, AND/OR DAMAGES FOLLOWING SUCH INJURY, DISABILITY, PARALYSIS, OR DEATH, EVEN IF CAUSED, IN WHOLE OR IN PART, BY THE NEGLIGENCE OF THE "RELEASEES" NAMED BELOW;

HEREBY RELEASE, DISCHARGE, AND COVENANT NOT TO SUE USA TABLE TENNIS, their respective administrators, directors, agents, officers, officials, volunteers, and employees, other participants, any sponsors, advertisers, and if applicable, owners and lessors of premises on which the Activity takes place, (each considered one of the "RELEASEES" herein) FROM ALL LIABILITY, CLAIMS, DEMANDS, LOSSES, OR DAMAGES ON MY ACCOUNT CAUSED OR ALLEGED TO BE CAUSED IN WHOLE OR IN PART BY THE NEGLIGENCE

OF THE "RELEASEES" OR OTHERWISE, INCLUDING NEGLIGENT RESCUE OPERATIONS; AND I FURTHER AGREE that if, despite this RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK, AND INDEMNITY AGREEMENT I and/or my minor child, or anyone on my and/or my minor child's behalf, makes a claim against any of the

Releases, I WILL INDEMNIFY, SAVE, AND HOLD HARMLESS EACH OF THE RELEASEES from any litigation expenses, attorney fees, loss, liability, damage, or cost which may incur as the result of such claim.

PERSONS IN POSITIONS OF AUTHORITY MUST BE FULLY SAFE SPORT COMPLIANT

Under USATT Safe Sport Policy, persons holding certain **Positions of Authority** must complete SafeSport Training offered by the US Center for Safe Sport (once per year) and undergo a criminal background screen (every two years). The list of Positions of Authority requiring **Full Safe Sport Compliance** is set out in USATT's Safe Sport Policy and the Athlete Safety Section of the USATT Website: <https://www.teamusa.org/usa-table-tennis/athlete-safety/safe-sport>.

USATT COACHING POLICY

All persons who are engaged in **coaching activities** at USATT Affiliated Member Clubs and/or USATT Sanctioned Tournaments, **except parents or legal guardians coaching their own children**, must be **Fully Safe Sport Compliant**, which requires completing SafeSport Training offered by the US Center for SafeSport every year and undergoing a criminal background screen every two years.

ADULT PARTICIPANTS REQUIRING SAFESPORT TRAINING

Pursuant to USATT's Minor Athlete Abuse Prevention Policy, **ALL Adult Participants** (participants over the age of 18) **who have regular contact with or authority over minor aged athletes** must complete SafeSport Training offered by the US Center for SafeSport every year ("SafeSport Trained").

CONTACT USATT TO BECOME SAFESPORT TRAINED AND/OR FULLY SAFE SPORT COMPLIANT USATT is pleased to assist USATT Members in the process of becoming SafeSport Trained and/or Fully Safe Sport Compliant. Please contact USATT at Admin@usatt.org for more information and guidance in this process.

MANDATORY REPORTING

There are certain circumstances where **reporting a potential Safe Sport violation is mandatory**. These circumstances include: (i) child abuse; (ii) sexual misconduct; (iii) emotional and physical misconduct; (iv) criminal charges and/or dispositions involving sexual misconduct or misconduct involving minors; (v) any abuse of the Safe Sport process. **Child abuse must be immediately reported to local law enforcement**. HOW TO REPORT SAFE SPORT VIOLATION

Persons can report a suspected violation of USATT's Safe Sport Policy to:

1. The US Center for SafeSport at www.SafeSport.org (or by phone during regular business hours at: 720- 531-0340); and/or
2. The USATT Athlete Protection Officer Mark Thompson (mark.thompson@usatt.org) (719-329-4200).

I understand USATT's Safe Sport Policy including the organization's Coaching Policy, which requires that all persons who are engaged in coaching activities at USATT Affiliated Member Clubs and/or USATT Sanctioned Tournaments, except parents or legal guardians coaching their own children, must be fully Safe Sport Compliant, which includes completing SafeSport Training offered by the US Center for SafeSport every year and undergoing a criminal background screen every two years.

I understand that, pursuant to USATT's Minor Athlete Abuse Prevention Policy, all participants at USATT Sanctioned Tournaments who are over the age of 18 and have regular contact with or authority over minor athletes must complete annual SafeSport Training offered by the US Center for SafeSport.
