RULES

Events can be cancelled or combined at the discretion of the tournament committee. No prize money or awards will be given for matches that are split, intentionally dumped, defaulted, not played, or affected by unsportsmanlike conduct, as determined by the Tournament Referee or Tournament Committee.

RATINGS CUTOFF

Ratings dated from Monday, May 11, 2026 from USATT website will be used for event eligibility. Seedings are based on the most current ratings. The tournament Director reserves the rights to assign ratings to unrated players for seeding purposes. Unrated players may enter rating events only at the discretion of the Tournament Director. Unrated players are not eligible to advance to cash-prize rounds in rating-restricted events unless assigned an estimated rating before the event. This restriction does not apply to the Unrated Event.

DEFAULTS

Players must check in at least 30 minutes before their first match and be ready to play 15 minutes before each scheduled match. A player who is not present when called may be defaulted. Entry fees will not be refunded for defaults, no-shows, or late arrivals. Prize money or awards may be forfeited for defaulted matches, matches not played as scheduled without approval, intentional dumping, match splitting, or unsportsmanlike conduct, as determined by the Tournament Referee or Tournament Committee.

Serious misconduct: In some cases, a default may occur due to disciplinary actions. For example, a player might be defaulted and potentially forfeit prize money for unsportsmanlike conduct or for a violation of tournament regulations.

MEMBERSHIP

Proof of USATT membership is required. Membership may be purchased along with tournament entry form.

Silver: \$50

Gold: \$100

Lifetime: \$1300

Tournament Pass: \$20

You may purchase a tournament pass even if you were previously a USATT member or have never purchased a tournament pass.

FORMAT/RATED: RR > SE

From the Round Robin groups, the top 2 players in each group will advance into the Single Elimination (SE) rounds.

FORMAT: GRR > SE

Format: Giant Round Robin will begin with preliminary round robin groups. Based on results, players will be placed into Championship/A/B/C divisions. The top two players from each divisional group will advance to single elimination.

DRESS CODE

White shirts, shorts, or skirts are not allowed during play.

PERSONS IN POSITIONS OF AUTHORITY MUST BE FULLY SAFE SPORT COMPLIANT

Under USATT Safe Sport Policy, persons holding certain Positions of Authority must complete SafeSport Training offered by the US Center for Safe Sport (once per year) and undergo a criminal background screen (every two years). USATT COACHING POLICY

ADULT PARTICIPANTS REQUIRING SAFE SPORT TRAINING

Pursuant to USATT's Minor Athlete Abuse Prevention Policy, ALL Adult Participants (participants over the age of 18 who have regular contact with or authority over minor aged athletes must complete SafeSport Training offered by the US Center for SafeSport every year ("SafeSport Trained")

MANDATORY REPORTING

1. IN CONSIDERATION of being permitted to participate in any way in USA Table Tennis sanctioned events, I and/or my minor child, our personal representatives, assigns, heirs, and next of kin:

2. ACKNOWLEDGE, agree, and represent that I and/or my minor understand the nature of Table Tennis Activities and that I and/or my minor child are qualified, in good health, and in proper physical condition to participate in such Activity. I further agree that if at any time I believe conditions or equipment to be unsafe, I and/or my minor child will immediately discontinue further participation in the Activity.

3. FULLY UNDERSTAND that (a) TABLE TENNIS ACTIVITIES INVOLVE RISKS AND DANGERS OF SERIOUS BODILY INJURY, INCLUDING PERMANENT DISABILITY, PARALYSIS AND DEATH, HARASSMENT, EXPOSURE TO INAPPROPRIATE CONDUCT AND LANGUAGE ("RISKS"); (b) these Risks and dangers may be caused by me and/or my child's own actions, or inaction, or the actions or inaction of others participating in the Activity, the condition in which the Activity takes place, or THE NEGLIGENCE OF THE "RELEASEES" NAMED BELOW; (c) there may be OTHER RISKS AND SEVERE SOCIAL AND ECONOMIC LOSSES either not known to me or not readily foreseeable at this time; and I FULLY ACCEPT AND ASSUME ALL SUCH RISKS AND ALL RESPONSIBILITY FOR LOSSES, COSTS, AND DAMAGES I and/or my minor child incur as a result of my participation in the Activity.
