Tournament Hotel: "Radisson Hotel Detroit-Farmington Hills," 31525 W 12 Mile Rd, Farmington Hills, MI 48334. Rate is \$79 a night + tax (free breakfast for two persons,) 1.5 miles away from the venue, mention 2020 MTTA February tournament to .

Equipment: Butterfly Centrefold 25, and Donic World Champion TC blue tables. Nittaku 3-star Premium 40+ white Balls; Tile flooring;

Format: All matches are 3 out of 5 games to 11 points. Giant round robins (event #1 & 2) are groups of 6 or 7 players to Single Elimination. Round robins (event# 3-16 except 11) are groups of 4 or 5 to Single Elimination. Unrated players will not advance except for the age event (Juniors U18) and the open singles event.

* Draw doubles RR is a fun event, you can't select your partner. We take the top half of the players into one pool and the bottom half into the second pool and do a blind/random draw to form the teams.

**U3800 doubles is a single elimination event. Combined ratings of players must be less than 3800.

Registration/Payment Deadline: 11:30pm, Feb 15, 2020.

Refunds: Full refund before the payment deadline. No refund after the registration/payment deadline.

Important: Payment must be made by deadline, or when you are contacted by the tournament director (when the event is full) to confirm your spot.

Policies: All USATT regulations apply including dress code. No prizes awarded for splits, dumps, defaults, or no-shows. Events might be cancelled if not enough players register or show up at the event. Do not enter 2 events at the same starting time.

USATT approved tiebreaking procedures will be used. No white shirts or white shorts. Any image, photographic or otherwise, taken of the tournament play or within the official venue is the property of USATT. Participants/spectators agree to allow their pictures, voices and likeness to be reproduced in connection with USATT by way of any medium.

Proof of Memberships: All Participants must show a proof of USATT membership for all events. Memberships and renewals are sold at the event. All players must either be current members or purchase a tournament pass for \$20. Membership fee: Adults \$75/yr; Juniors/college \$45/yr; Family \$150/yr.
