Eligibility: Open to all members of USA Table Tennis (USATT). Non-members may join the USATT by including the membership fee with their entry fee. Players who are not current USATT members may buy a basic Membership for \$25.

Omnipong: Players should enter on the web and pay at stadiumtt.com. Enter with your USATT # if available.

Unpaid entries may be removed from Stadiumtt. Unrated players should submit estimated rating, also include contact information of source for estimated rating.

Deadline: Saturday, October 25, 2025. Entry fees must accompany entry form.

Refunds: No refunds after Deadline. Refunds (less \$15 administrative fee) available prior to deadline upon request.

Reporting and Starting Times: Players must check-in at the control desk before 8:45am, play begins at 9:00am. The control desk will allow check-ins beginning at 8:30am. Players that arrive late may be defaulted for the entire event (and replaced by an alternate) at the discretion of the referee.

Practice: The gym will be open for practice at 8:00 a.m.

Umpires: Provided upon request, if available.

Rules: The Laws of Table Tennis as published by the ITTF and all USATT regulations will be enforced.

Equipment: Only USATT approved equipment will be used. 16 Donic tables and nets; white Nittaku ★★★ Premium 40+ (plastic) balls; wooden floors.

- Rackets - One side of the racket must be bright red or another color recently approved by ITTF, the other side black. No complete regluing unless it is a new sheet of rubber. Partial re-gluing may be done with the permission of and under supervision of the referee.

- Clothing – The USATT Dress Code applies. The main color of the body of the shirt or shorts or hat may not be white. Please dress in appropriate athletic attire. Designs or lettering that are distracting to an opponent or are offensive will not be permitted. Rubber-soled, non-marking, shoes must be worn.

Format: Giant Round Robin

\$90 per Player(\$75 event fee plus \$15 administrative fee). 64 player limit. Only 5 players under 1000 rating will be accepted

Top 4 entries will be seeded into Championship draw in second round. All players advance to second round of Championship, Class AA, or Class A, B, C, D. Play will be in Three Stages: ▪ Preliminary: Begins at 9:00am. 10 groups of 6 players complete a round robin. ▪ Stage 2: Begins at 1:00pm. Based on playing records in the Preliminary groups, players will be placed into class round robin events. Each event will have 2 groups of 5-7 players. ▪ Stage 3: Begins at approximately 4:00pm. Single elimination of group winners and runners-up. ▪ All games will be to 11 points; Championship event best of 7 for final match only; all other matches are best of 5 games. • • Awards: Championship – 1 st \$1,000, 2 nd \$350, Semi-finalists \$100 each; Class AA - 1 st \$150, 2nd \$75; Class A - 1 st \$75; Class B 1st \$75. Trophies for 1 st and 2nd in all events
