Cancellations made after May 20th will not be refunded

*Players may enter multiple events, but those rated U1900

will be put on a waiting list for the O1900 event,

and those O1900 will be given priority in rating order from high to low for the O1900 event, if space allows it.

Players must be USATT members (\$25/yr Basic; \$75/yr Pro Membership) – USATT membership can be renewed upon arrival.

Tournament Committee reserves the right of acceptance or refusal of all tournament entries.

Qualification Ratings will be taken as of May 20th, 2021 from the USATT website

Playing Format:

- *Under 1350* - Players will be placed into 4-6-person Round Robin groups (possibly larger dependent upon the # of entries), in which top 2-3 players from each group will advance to a Single Elimination Playoff.
- *Under 1900 & Over 1900* - Group size will range from 7-10 players (dependent upon the # of entries - the tournament director may opt to seed out the highest rated players in the O1900 event)
 - o Round 2 - Top 4 players from each RR will advance to a Single Elimination Round
 - o Round 3 - Players will play a SE round until the Finals to determine the winner
