1. Tournament management may modify, combine, or cancel events, limit total entrants, or total entries by event. Fees for cancelled events will be refunded.
2. USATT dress code & all other USATT rules will be enforced. Do not wear white clothing as the ball is white.
3. All events will be 3 out of 5 games
4. 2 players will advance each RR.
5. **DO NOT ENTER** 2 events with *same starting time*.
6. *Maximum* of **3 events PER DAY**.
7. Unrated players may enter any event. However, they are NOT guaranteed to advance from any rating events EXCEPT in Open Singles & Age Events.
8. Players must be USATT members, or join by the tournament date.
9. Age cutoff for Over 50/70 events is as of 12/31/2026.
Age cutoff for any Junior events is as of 12/31/2026.
10. Ratings as of 10/8/2026 will be used for eligibility. The most recent rating will be used for seeding.
11. *Maximum player rating for U3600 doubles is 2200 per player.*
12. Any image, photographic or otherwise, of tournament play or with in the official venue is the joint property of USA Table Tennis (USATT) and LYTTC. Entrants agree to allow their voice, image, likeness, and/or any other representation to be broadcast, by USATT and/or LYTTC.
13. Withdrawals up through 10/05/2026 will be eligible for full refunds. ***Entry Deadline: Must be received by Thursday, October 8, 2026***
