ELIGIBILITY: Open to all USATT members. Regular USATT memberships or Associate Memberships / Tournament Passes are available on this entry form.

FORMAT: Double-Round Robin. 18t Round: Players will be grouped using the "snake "system per USATT Tournament Guide. 2nd Round: All players will advance to Elite, A, B, or C Divisions, depending upon the Win/Loss records and number of players. Ties will be broken in accordance with the USATT Tournament Guide. All matches will be 3 out of 5 games.

Divisions may be modified depending upon attendance.

SCHEDULE: Play starts at 9:00 **am**. Players must register no later than **30 minutes prior** to the start time. Players who are not on time may be defaulted and/or replaced by alternate players.

EVENTS: Singles: Double Round Robin (Maximum 50 players)

The director reserve the right to modify any event for reasons of insufficient participation.

Ball: Nittaku 3-Star 40+ White Color

RACKETS: ITTF/USATT `approved Black & a different color.

CLOTHING: White and very light colors are not allowed.

The USATT Dress Code applies: 3.2.2.2 The primary color of a shirt, skirt, or shorts, other than the sleeves and collar of a shirt, shall be clearly different from that of the ball in use. See the example

RULES: The Laws of Table Tennis by the ITTF and all USATT regulations will be enforced.



USATT SAFE SPORT PROTOCOL ENTRY BLANK TEMPLATE FOR USATT SANCTIONED TOURNAMENTS

I understand USATT's Safe Sport Policy including the organization's Coaching Policy, which requires that all persons who are engaged in coaching activities at USATT Affiliated Member Clubs and/or USATT Sanctioned Tournaments, except parents or legal guardians coaching their own children, must be fully Safe Sport Compliant, which includes completing SafeSport Training offered by the US Center for SafeSport every year and undergoing a criminal background screen every two years.
I understand that, pursuant to USATT's Minor Athlete Abuse Prevention Policy, all participants at USATT Sanctioned Tournaments who are over the age of 18 and have <u>regular contact with or authority over</u> minor athletes must complete annual SafeSport Training offered by the US Center for SafeSport.
