FORMAT: All matches are 3 out of 5 games to 11 points. Groups will be either 6 or 7 players.

Top 4 players from each group advance to SE playoff. The tournament director reserves the right to change the draw limit for any event depending on the number of registrants. No prize money awarded for de-faults, splits, or unfinished matches. USATT dress code enforced. No white clothing.

ENTRY POLICY/RATINGS: USATT ratings as of August 26 2022 will be used for all events.

ENTRY DEADLINE: Entries must be received by August 19th 12pm. Late entries will be accepted with a **\$10 late fee** by email or at the door at least one hour prior to event start time, space permitting.

ELIGIBILITY: Players must be USATT members or members of an ITTF affiliated association. Non-members may join the USATT with their entry. Unrated players may NOT advance in rated events.

REFUND POLICY: Withdrawal needs to be made by the entry deadline or entry fee will be forfeited.

USATT MEMBERSHIP: BASIC Plan is \$25/yr. PRO plan is \$75/yr. Any player that is not a current USATT member must either purchase a membership or a Tournament Pass for \$20.

DEFAULT POLICY: Players not signed in within 10 minutes after an event's starting time maybe defaulted.
