Please Check in 30 minutes early before your event start. Players can't participate in 2 events starting at the same time. Events may be cancelled or modified at the discretion of the tournament committee.

**Equipment**: 14 USATT approved tables (Butterfly National League 25 Table & Easifold DX 22 Table), wood flooring, very good light, 3-star Nittaku premium white balls 40+ will be used, good size courts, and small lounge.

**Format:** All matches are best 3 out of 5 games. Two players advance (Any Singles) from Round Robin to Single Elimination for all Single events, normally it is either 3 or 4 players in each group for all events. **Both U2300 and U2150 top 4 players may bye on the RR, Open Singles top 8 ratings players may bye on the RR.** 

**Rules:** All USATT regulations, including equipment, conduct, dress, and language apply. Please DO NOT wear white clothing because the ball is white.

**Proof of Membership:** Must show the proof of USATT membership for events. Membership and renewals sold at the event. Basic Yearly Membership \$25, Pro Yearly Membership \$75

**Entry Deadline:** All mail/email/online must be received by Dec. 29<sup>th</sup>. No refunds after Dec. 30<sup>th</sup>, 2025 unless the event is canceled. **Refunds** will be given for the cancelled events by the tournament committee.

#### PERSONS IN POSITIONS OF AUTHORITY MUST BE FULLY SAFE SPORT COMPLIANT

Under USATT Safe Sport Policy, persons holding certain **Positions of Authority** must complete SafeSport Training offered by the US Center for Safe Sport (once per year) and undergo a criminal background screen (every two years). The list of Positions of Authority requiring **Full Safe Sport Compliance** is set out in USATT's Safe Sport Policy and the Athlete Safety Section of the USATT Website: <a href="https://www.teamusa.org/usa-table-tennis/athlete-safety/safe-sport">https://www.teamusa.org/usa-table-tennis/athlete-safety/safe-sport</a>.

#### USATT COACHING POLICY

All persons who are engaged in coaching activities at USATT Affiliated Member Clubs and/or USATT Sanctioned Tournaments, except parents or legal guardians coaching their own children, must be Fully Safe Sport Compliant, which requires completing SafeSport Training offered by the US Center for SafeSport every year and undergoing a criminal background screen every two years.

#### ADULT PARTICIPANTS REQUIRING SAFESPORT TRAINING

Pursuant to USATT's Minor Athlete Abuse Prevention Policy, <u>ALL Adult Participants</u> (participants over the age of 18) who have regular contact with or authority over minor aged athletes must complete SafeSport Training offered by the US Center for SafeSport every year ("SafeSport Trained").

#### CONTACT USATT TO BECOME SAFESPORT TRAINED AND/OR FULLY SAFE SPORT COMPLIANT

USATT is pleased to assist USATT Members in the process of becoming SafeSport Trained and/or Fully Safe Sport Compliant. Please contact USATT at <a href="mailto:Admin@usatt.org">Admin@usatt.org</a> for more information and guidance in this process.

#### MANDATORY REPORTING

There are certain circumstances where reporting a potential Safe Sport violation is mandatory. These circumstances include: (i) child abuse; (ii) sexual misconduct; (iii) emotional and physical misconduct; (iv) criminal charges and/or dispositions involving sexual misconduct or misconduct involving minors; (v) any abuse of the Safe Sport process. Child abuse must be immediately reported to local law enforcement.
