Entry Deadline: Saturday, October 19, 2024. \$5 for late entries. No Refund after October 19, 2024.

Eligibility For Event: Open to all members of USA Table Tennis (USATT). Non-members may join the USATT by including the membership fee with their entry fee. Players who are not current USATT members may buy a basic annual Membership pass for \$25.

Rules: The Laws of Table Tennis as published by the ITTF and all USATT regulations will be enforced.

Equipment: Butterfly Europa/Centrefold 25 tables/nets, Joola 3000sc tables/nets, & Nittaku Premium 3-star 40+mm white plastic balls. Red rubber floor. ITTF/USATT approved equipment only.

Format: Two Round Robins and single elimination playoff. Players will be placed into 4 or 5 players each group based on player's ratings by snack system for the first round robin. All players advance to different divisions after the first round robin play. The second round robin play is 3 or 4 players grouped based on the performance in the first round robin.

Group info will be emailed after October 22th, 2024. Group #1 to #4 will check in at 11:15am. Players in the other groups (# 5 and beyond) must check-in at the control desk before 8:45am and play begins at 9:00am. U4000 Doubles will be at 5:00pm. The court will open for practice Friday, 4:00pm-8:45pm and Saturday, 8:00am-8:45am.

All matches are best of 5 games. All games will be to 11 points. Championship final match is best of 7.

Play will be in three stages:

Preliminary: The first round robin. Top two finishes advance to Championship. The 3rd & 4th players advance to Class A. The other players will go into Class B.

- Stage 2: The second round robin. Top 2 players advance to single elimination in Championship, Class A, and Class B accordingly.
- Stage 3: Single elimination play off.

Doubles will be single elimination if more than 6 teams (or RR-SE) with best of 5 games.

Cancellation: Director reserves the right to modify any event, cancel the event/tour, restrict the number of players in the tournament, and change formats as necessary. The entry fee and administration fee will be refunded if the event is cancelled by organizer. \$5 non-refundable administration fee for cancellations prior to deadline upon player's written request and the entry fee will be refunded. NO REFUNDS AFTER October 19th. THANK YOU!

UPSETS CASH AWARDS: (Note: Thank KTTC for allowing us to use its Gold Dollar Awards format.) BHTT reserves \$200 for Upsets Awards in Open Single event, which will be proportionately divided into both of Group #1-#4 and Group #5+. This prize money can be won by all level of USATT rated players; not just the top players. The only criteria to win Upsets Awards is to upset a player whose USATT rating is higher than yours. Bring your match score sheet to control desk for Upsets Awards if you do have an upset won and reserved Upsets Awards funds are still available.

The rules for winning for single play are:

- 1. Upsets Awards will be paid to winners of all upsets in a match in which both players must be USATT officially rated (not estimated rating or unrated).
- Winners of each upset will receive Upsets Awards using the following payout schedule: Rating difference: 100 or less, UPSETS AWARDS reward is up to \$5.00 Rating difference: 101 to 150, UPSETS AWARDS reward is up to \$10.00 Rating difference: 150 or larger, UPSETS AWARDS reward is up to \$15.00
- 3. The Upsets Awards will be paid immediately upon confirmation of match sheets showing upsets on a first come first get paid basis in the same play stage until funds run out. So sharpen your game and hit the court running fast!
- 4. Rating used to determine the upsets will be the USATT ratings of record as of 9:00 am, Friday October 25th , 2024.

USATT COACHING POLICY

All persons who are engaged in coaching activities at USATT Affiliated Member Clubs and/or USATT Sanctioned Tournaments, except parents or legal guardians coaching their own children, must be Fully Safe Sport Compliant, which requires completing SafeSport Training offered by the US Center for SafeSport every year and undergoing a criminal background screen every two years.

ADULT PARTICIPANTS REQUIRING SAFESPORT TRAINING

Pursuant to USATT's Minor Athlete Abuse Prevention Policy, <u>ALL Adult Participants</u> (participants over the age of 18) who have regular contact with or authority over minor aged athletes must complete SafeSport Training offered by the US Center for SafeSport every year ("SafeSport Trained").

CONTACT USATT TO BECOME SAFESPORT TRAINED AND/OR FULLY SAFE SPORT COMPLIANT

MANDATORY REPORTING

There are certain circumstances where **reporting a potential Safe Sport violation is mandatory**. 
