**Format**: Preliminary Round Robin matches with groups of 5 players, 2 players advancing to single elimination playoff matches. (Limit of 4 en tries for players with rating lower than 1000 for the U2000 event). Format subject to change depending on number of entries.

**Eligibility**: USATT membership required, new members need to buy a membership (\$75/yr pro-membership or \$25/yr for basic members). Ratings and new membership will be processed by USATT after the tournament.

**Equipment**: ITTF approved Joola and Stag tables. Nittaku 3\* Premium 40+ balls. ITTF approved red rubber floor mat on all tables and 500 lux lighting

- All USATT regulations, including equipment, conduct, dress, and language apply.
- All matches are best of 5 games to 11 points.
- Players must arrive at least 30 minutes before the starting time.
- Ratings as of April 23<sup>rd</sup>, 2025 will be used to establish eligibility and seeding.
- Estimated ratings for new players may be accepted from USATT certified coaches.
- Un-rated players will not advance from the Round Robin
- Players cannot advance if matches are defaulted / forfeited
- No prize money will be awarded for defaults and forfeits
- All decisions made by tournament referee and/or director will be final.
- Prize(s) may be forfeited if the match is not played unless approved by the tournament director.
- Events may be canceled/modified if needed. In the event of cancelation, fees will be refunded.

#### Release and Waiver of Liability, Assumption of Risk, and Indemnity Agreement

("Agreement")

- 1. IN CONSIDERATION of being permitted to participate in any way in EC Sports events, I and/or my minor child, our personal representatives, assigns, heirs, and next of kin:
- 2. ACKNOWLEDGE, agree, and represent that I and/or my minor understand the nature of Table Tennis Activities and that I and/or my minor child are qualified, in good health, and in proper physical condition to participate in such Activity. I further agree that if at any time I believe conditions or equipment to be unsafe, I and/or my minor child will immediately discontinue further participation in the Activity.
- 3. FULLY UNDERSTAND that (a) TABLE TENNIS ACTIVITIES INVOLVE RISKS AND DANGERS OF SERIOUS BODILY INJURY, INCLUDING PERMANENT DISABILITY, PARALYSIS AND DEATH, HARASSMENT, EXPOSURE TO INAPPROPRIATE CONDUCT AND LANGUAGE ("RISKS"); (b) these Risks and dangers may be caused by me and/or my child's own actions, or inaction, or the actions or inaction of others participating in the Activity, the condition in which the Activity takes place, or THE NEGLIGENCE OF THE "RELEASEES" NAMED BELOW; (c) there may be OTHER RISKS AND SOCIAL AND ECONOMIC LOSSES either not known to me or not readily foreseeable at this time; and I FULLY ACCEPT AND ASSUME ALL SUCH RISKS AND ALL RESPONSIBILITY FOR LOSSES, COSTS, AND DAMAGES I and/or my minor child incur as a result of my participation in the Activity.
- 4. HEREBY ACCEPT AND ASSUME ALL SUCH RISKS, KNOWN AND UNKNOWN, AND ASSUME ALL RESPONSIBILITY FOR THE LOSSES, COSTS, AND/OR DAMAGES FOLLOWING SUCH INJURY, DISABILITY, PARALYSIS, OR DEATH, EVEN IF CAUSED, IN WHOLE OR IN PART, BY THE NEGLIGENCE OF THE "RELEASEES" NAMED BELOW;
- 5. HEREBY RELEASE, DISCHARGE, AND COVENANT NOT TO SUE EC Sports Table Tennis or Blue Shark Sports, their respective administrators, directors, agents, officials, volunteers, and employees, other participants, any sponsors, advertisers, and if applicable, owners and lessors of premises on which the Activity takes place, (each considered one of the "RELEASEES" herein) FROM ALL LIABILITY, CLAIMS, DEMANDS, LOSSES, OR DAMAGES ON MY ACCOUNT CAUSED OR ALLEGED TO BE CAUSED IN WHOLE OR IN PART BY THE NEGLIGENCE OF THE "RELEASEES" OR OTHERWISE, INCLUDING NEGLIGENT RESCUE OPERATIONS; AND I FURTHER AGREE that if, despite this RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK, AND INDEMNITY AGREEMENT I and/or my minor child, or anyone on my and/or my minor child's behalf, makes a claim against any of the Releases, I WILL INDEMNIFY, SAVE, AND HOLD HARMLESS EACH OF THE RELEASEES from any litigation expenses, attorney fees, loss, liability, damage, or cost which may incur as the result of such claim
- 6. #### PERSONS IN POSITIONS OF AUTHORITY MUST BE FULLY SAFE SPORT COMPLIANT

Under USATT Safe Sport Policy, persons holding certain **Positions of Authority** must complete SafeSport Training offered by the US Center for Safe Sport (once per year) and undergo a criminal background screen (every two years). The list of Positions of Authority requiring **Full Safe Sport Compliance** is set out in USATT's Safe Sport Policy and the Athlete Safety Section of the USATT Website: <a href="https://www.teamusa.org/usa-table-tennis/athlete-safety/safe-sport">https://www.teamusa.org/usa-table-tennis/athlete-safety/safe-sport</a>.

#### USATT COACHING POLICY

All persons who are engaged in coaching activities at USATT Affiliated Member Clubs and/or USATT Sanctioned Tournaments, except parents or legal guardians coaching their own children, must be Fully Safe Sport Compliant, which requires completing SafeSport Training offered by the US Center for SafeSport every year and undergoing a criminal background screen every two years.

#### ADULT PARTICIPANTS REQUIRING SAFESPORT TRAINING

Pursuant to USATT's Minor Athlete Abuse Prevention Policy, <u>ALL Adult Participants</u> (participants over the age of 18) who have regular contact with or authority over minor aged athletes must complete SafeSport Training offered by the US Center for SafeSport every year ("SafeSport Trained").

#### CONTACT USATT TO BECOME SAFESPORT TRAINED AND/OR FULLY SAFE SPORT COMPLIANT

USATT is pleased to assist USATT Members in the process of becoming SafeSport Trained and/or Fully Safe Sport Compliant. Please contact USATT at <a href="mailto:Admin@usatt.org">Admin@usatt.org</a> for more information and guidance in this process.

#### MANDATORY REPORTING

There are certain circumstances where **reporting a potential Safe Sport violation is mandatory**. These circumstances include: (i) child abuse; (ii) sexual misconduct; (iii) emotional and physical misconduct; (iv) criminal charges and/or dispositions involving sexual misconduct or misconduct involving minors; (v) any abuse of the Safe Sport process. **Child abuse must be immediately reported to local law enforcement.** To learn more about the appropriate agency where you can submit a report of child abuse, log onto: https://www.childwelfare.gov/topics/responding/reporting.
