There will be an A and B division of 3 person teams with an optional 4th player alternate.

- Division A will be capped at a 5200 rating between the top 3 players. There will be no individual rating cap.
- Division B will be capped at a 4200 rating between the top 3 players. No individual player shall be rated above 1700.

**Ratings:** Current highest rating between regional and USATT Ratings will be used for seeding. If no USATT rating is available, regional or club ratings will be used.
