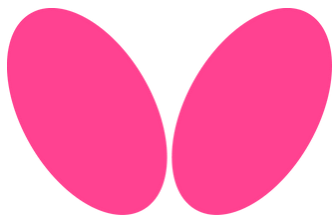

SYSTEM OF PLAY:

Event 1-5: All matches excluding those in Event 6, are best 3 out of 5 games. Two players advance from Round Robin to Single Elimination.

Event 6 HANDICAP: All games will be straight to 32pts with no deuce while still adopting the 2 serve method in traditional table tennis matches. The lower rated player will start the match with points advantage depending on the USATT rating disparity with opponent. A handicap points chart will be provided at the club to determine the points advantage. This particular event will NOT be recorded against the USATT ratings.
