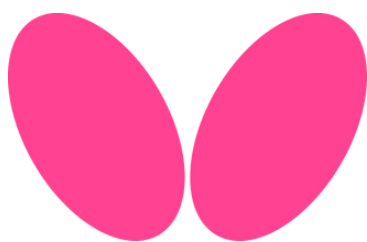

Two players or team advance from Round Robin to Single Elimination.

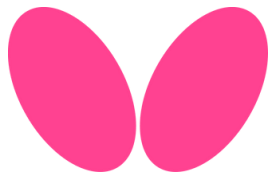

**USATT SAFE SPORT PROTOCOL FOR USATT SANCTIONED TOURNAMENTS:**
