1. All events are a combination of round robin & single elimination format, except for: all doubles, Over 40, which are SE.
2. All matches are 3/5 (*Dan Seemiller Singles Championship Final is Best of 7).
3. Two players advance from each round group to a single elimination tournament during the April 25 tournament. April 26 is a giant round robin of 8 players in 7 different divisions-no single elimination playoffs. Providing that participation permits.
4. **Events 14 (Clinic) and 15 (Giant RR) are NOT on Saturday:** Clinic is April 24 and Giant RR is Apr. 26.
5. No players in the Doubles U2200 may have a rating over 1500.

Policies: All USATT Regs apply including dress code, no prizes awarded for splits, dumps, defaults, or no-shows. Events may be modified as per discretion of directors. No white clothing. Must be present 10 minutes prior to match time. Unrated players will **NOT** advance. All images of tourney play or of venue is property of EKTT and The Butterfly Dan Seemiller Classic TM ©. Giant Round Robin Format: Players will be placed in groups of 8 (providing participation allows), which gives each player seven matches per division/group. Grouping will be determined by player rating as of April 2, 2026. The top 8 rated players will be placed in Division 1, then the next 8 in Division 2, and so forth, until the tournament is full. Each player’s finish will be determined by their win-loss record and the standard tie-breaking rules will apply. There is NO second tier play off, or single elimination round following the giant round robin group play. Some groups may be combined if attendance doesn’t allow a full grouping of 8 players.

RULES AND REGULATIONS/VENUE/OFFICIALS

- 1.** Tournament management may modify, combine, or cancel events, limit total entrants, or total entries by event. Fees for cancelled events will be refunded.
- 2.** USATT dress code & all other USATT rules will be enforced.
- 3.** All events will be on EST (Eastern Standard Time) and be 3 out of 5 games matches. Enter Early...
- 4.** Dan Seemiller Singles Championship Final will be Best 4 out of 7 games.
- 5.** DO NOT ENTER 2 events with same starting time or more than 4 total events.
- 6.** Unrated players may enter any event; however, they will NOT advance from any rated restricted round robin.
- 7.** All events with the exception of Event #5 are open to USATT members or those who join. Event #5 may be entered by invitation only. Ratings will be used for seeding.
- 8.** Ratings as of 2/27/2026 will be used for eligibility. Ratings for seeding will be from 4/15/2026.
- 9.** Withdrawals up through 4/15/2026 will be eligible for full refunds.
- 10.** Any image, photographic or otherwise, of tournament play or within the official venue is the joint property of USA Table Tennis (USATT) and EKTT. Entrants agree to allow their voice, image, likeness, and/or any other representation to be broadcast, reproduced, or publicized by way of any medium as determined by USATT and/or SBTTTC.

- 12.** If any player has not paid in full by April 15-they will **NOT** be allowed in the draw.

PERSONS IN POSITIONS OF AUTHORITY MUST BE FULLY SAFE SPORT COMPLIANT

Under USATT Safe Sport Policy, persons holding certain **Positions of Authority** must complete SafeSport Training offered by the US Center for Safe Sport (once per year) and undergo a criminal background screen (every two years). The list of Positions of Authority requiring **Full Safe Sport Compliance** is set out in USATT's Safe Sport Policy and the Athlete Safety Section of the USATT Website: <https://www.teamusa.org/usa-table-tennis/athlete-safety/safe-sport>.

USATT COACHING POLICY

All persons who are engaged in **coaching activities** at USATT Affiliated Member Clubs and/or USATT Sanctioned Tournaments, **except parents or legal guardians coaching their own children**, must be **Fully Safe Sport Compliant**, which requires completing SafeSport Training offered by the US Center for SafeSport every year and undergoing a criminal background screen every two years.

ADULT PARTICIPANTS REQUIRING SAFESPORT TRAINING

Pursuant to USATT's Minor Athlete Abuse Prevention Policy, **All Adult Participants** (participants over the age of 18) who **have regular contact with or authority over minor aged athletes** must complete SafeSport Training offered by the US Center for SafeSport every year ["SafeSport Trained"].

CONTACT USATT TO BECOME SAFESPORT TRAINED AND/OR FULLY SAFE SPORT COMPLIANT

USATT is pleased to assist USATT Members in the process of becoming SafeSport Trained and/or Fully Safe Sport Compliant. Please contact USATT at Admin@usatt.org for more information and guidance in this process.

MANDATORY REPORTING

There are certain circumstances where **reporting a potential Safe Sport violation is mandatory**. These circumstances include: (i) child abuse; (ii) sexual misconduct; (iii) emotional and physical misconduct; (iv) criminal charges and/or dispositions involving sexual misconduct or misconduct involving minors; (v) any abuse of the Safe Sport process. **Child abuse must be immediately reported to local law enforcement**. HOW TO REPORT SAFE SPORT VIOLATION

I understand USATT's Safe Sport Policy including the organization's Coaching Policy, which requires that all persons who are engaged in coaching activities at USATT Affiliated Member Clubs and/or USATT Sanctioned Tournaments, except parents or legal guardians coaching their own children, must be fully Safe Sport Compliant, which includes completing SafeSport Training offered by the US Center for SafeSport every year and undergoing a criminal background screen every two years.

I understand that, pursuant to USATT's Minor Athlete Abuse Prevention Policy, all participants at USATT Sanctioned Tournaments who are over the age of 18 and have **regular contact with or authority over** minor athletes must complete annual SafeSport Training offered by the US Center for SafeSport.
