Governance : All USATT Rules apply.

Format : All Matches are best 3 out of 5 games to 11pts. Two players advance (Any Singles) from round robin to single elimination for all single events. It will be either 4 or 5 players in each group usually. Two teams from each group advance to semifinals for the Doubles events.

Check-in: 20 min. prior to start time.

Equipment: 3-Star Nittaku 40+ white balls made in Japan Plastic balls will be used on 4 Butterfly Octet25 tables on hardwood flooring.

Ratings: USATT website ratings as of June 10, 2025. Unrated players must be approved by the tournament committee and assigned a rating to play in any rated event. **NO WHITE SHIRTS ALLOWED.**

Proof of Membership: Must show the proof of USATT membership at the events. Basic yearly membership is \$25 and Pro Yearly membership \$75.

Entry deadline: All mail/email/online registrations must be received by June 15, 2025. No refunds after Feb 18, 2025 unless the event is canceled.

ACKNOWLEDGE, agree, and represent that I and/or my minor understand the nature of Table Tennis Activities and that I and/or my minor child are qualified, in good health, and in proper physical condition to participate in such Activity. I further agree that if at any time I believe conditions or equipment to be unsafe, I and/or my minor child will immediately discontinue further participation in the Activity.

USATT SAFE SPORT PROTOCOL ENTRY BLANK TEMPLATE FOR USATT SANCTIONED TOURNAMENTS

I understand USATT's Safe Sport Policy including the organization's Coaching Policy, which requires that all persons who are engaged in coaching activities at USATT Affiliated Member Clubs and/or USATT Sanctioned Tournaments, except parents or legal guardians coaching their own children, must be fully Safe Sport Compliant, which includes completing SafeSport Training offered by the US Center for SafeSport every year and undergoing a criminal background screen every two years.
