FORMAT / SCORING:

Players	Format	Matches / Player	Match Format
14	Full Round Robin	13	Best 2 of 3 Games

All 14 players will compete in one full round robin, with each player playing the other 13 players once. The event will be played over 13 rounds: Rounds 1–8 will be played first, followed by a 30-minute break, and then Rounds 9–13. All matches in each round will begin at the same time, and the next round will not begin until all matches in the current round are finished. Each match is best 2 of 3 games, with each game being played to 11 points and must be won by at least 2 points. Final standings will be based on total match wins. If two players are tied, the head-to-head result will determine the higher position. If three or more players are tied, results among the tied players will be considered first, followed by game ratio and then point ratio if necessary.

Registration: Invitation only - Players must be invited by Coach Jiaqi.

Age Eligibility: Players must be born on or after October 4, 2015. Players born on or before October 3, 2015 are not eligible.

Rating Eligibility: Players must have an official or estimated rating below 500. Unrated players may participate if the Tournament Director determines that their playing level is appropriate for the event. The Tournament Director has final authority on rating eligibility.

Deposit Policy: A \$100 refundable cash deposit is required for each player. A written receipt will be provided when the deposit is received. The deposit will be returned after the player completes the tournament. If a player withdraws after the entry deadline, is a no-show, or does not complete the event, the deposit may be forfeited at the discretion of the Tournament Director, except in the case of injury or other approved circumstances.

PLAYING AREA POLICY:

Parents, guardians, coaches, and spectators must remain outside the designated playing area during competition. No coaching or match-related instructions may be given during a match, including during intervals between games. Violations will be strictly enforced and may result in a warning, removal from the playing area or facility, match forfeiture, player disqualification, and/or forfeiture of the deposit, at the discretion of the Tournament Director.

RULES:

The club will open for warm-up 1 hour before the tournament starts, and all players must check in at least 30 minutes before the start time. Pre-match warm-up is limited to 2 minutes. Players must be present and ready when their round is called. White shirts, jerseys, or other predominantly white upper-body clothing are not permitted during competition. All players must follow applicable table tennis rules, equipment requirements, conduct standards, and dress requirements. All decisions of the Tournament Director regarding tournament administration, scheduling, rule enforcement, and standings are final.
