- **Weekly Prizes for all divisions including cash prizes for first two**
- **Each Division will have 6 or more players in the second stage and a max of 10. League results may be submitted for USATT League ratings**
- If the top 6 seeds by ratings among all players at the beginning of the month end up in Division 2 or lower for week 2 by not finishing in the Top 4 of the respective 8-person group in first week, such players cannot win Prize money and or awards in Division 2 or lower.
- The most recent USATT ratings / Or League ratings available will be used for seeding the players for events on stadium compete ratings system, if a players USATT league rating has more than 100 points difference with USATT Ratings and is prior to 2024 then the most recent ratings will be used.
- *Note: Tournament committee reserves the right to deny prize money and/or awards to sandbagging players*
- Seasonal awards will be provided based on the combined results from all 6 weeks. Ties will be broken down using existing USATT rules across all matches played over 6 weeks.
- *Starting from Monday of each week before the league start date, players who have not made the entry fee payment will be removed from the participant list automatically and the spot will be made open to the next paying participant. Platforms like Omni Pong and or stadium compete may not reflect the actual list of participants* which are maintained Separately by CITTA organizing committee
- Players must register at the desk or check in online at stadiumcompete.com no later than 60 minutes before the start time.
- Pre-match warm-up will be limited to 2 minutes.
- Unrated players will be given an estimated rating based on a recommendation by a coach who knows the player or by visual evaluation of the player by a coach, whenever possible. Unrated players may not win prize money or trophies except for top division.
- Any image, photographic, video or otherwise, taken of the tournament play or within the official venue is essentially the property of CITTA (Chicago International Table Tennis Academy) and USATT. Entrants agree to allow their picture, video, voice and likeness to be reproduced in connection with CITTA or USATT by way of any medium.
- USATT Dress Code applies. The main body of the shirts, shorts and skirts must be significantly different than the color of the ball **(White). No White shirts, shorts and skirts allowed.**
- All USATT regulations apply. Only USATT approved equipment will be used: 10 blue Butterfly Centerfold Table Tennis Table and **White 3-star Premium 40 + Joola plastic balls.**
- *For matches to be counted for the league results and standings all league balls must be returned to CITTA by respective players from Groups and Divisions*
- *Purchase of Seasonal pass and/or weekly pass is not guaranteed for a spot to play in the league. Seasonal and weekly league pass holders still need to sign up for each week at least 24hrs before start time and check in at least 1hr before play begins. Midnight before league starts registration closes and check-in will close online 1hr before start. Open Spots will be filled based on first come first serve basis for players at the venue. Open Spots will be filled up by players who are waiting at the venue within 1 hr. of league play start time.*
- *Season and Weekly passes are not transferable to another individual and cannot be applied or carried on to a different Season or a week(s).*

LEAGUE PARTICIPANT WAIVER

IN CONSIDERATION of being permitted to participate in any way in USA Table Tennis affiliated club events and leagues, I and/or minor child, our personal representatives, assigns, heirs, and next of kin, I:

ACKNOWLEDGE, agree, and represent that I and/or minor-aged child understand the nature of Table Tennis Activities, including but not limited to risks involved in the sport itself together with all risks, known and unknown, associated with gatherings of people ("Activities"), including the exposure to COVID-19, coronavirus, or other infectious organisms or diseases; and that I and/or minor child are qualified, in good health, and in proper physical condition to participate in such Activities. I further agree that if at any time I believe conditions or equipment to be unsafe, I and/ or minor child will immediately discontinue further participation in the Activities.

FULLY UNDERSTAND that (a) TABLE TENNIS ACTIVITIES INVOLVE RISKS AND DANGERS OF SERIOUS BODILY INJURY, INCLUDING PERMANENT

DISABILITY, PARALYSIS, DISMEMBERMENT, AND DEATH ("RISKS"); (b) these Risks and dangers may be caused by me and/or minor child's own actions, or inaction, or the actions or inaction of others participating in the Activities, the condition in which the Activities takes place, or THE NEGLIGENCE OF THE "RELEASEES" NAMED BELOW; (c) there may be OTHER RISKS AND SEVERE SOCIAL

AND ECONOMIC LOSSES either not known to me or not readily foreseeable at this time; and I FULLY ACCEPT AND ASSUME ALL SUCH RISKS AND ALL RESPONSIBILITY FOR LOSSES, COSTS, AND DAMAGES I and/or minor child incur as a result of my participation in such Activities.

HEREBY ACCEPT AND ASSUME ALL SUCH RISKS, KNOWN AND UNKNOWN, AND ASSUME ALL RESPONSIBILITY FOR THE LOSSES, COSTS, AND/ OR DAMAGES FOLLOWING SUCH INJURY, DISABILITY, PARALYSIS, OR DEATH, EVEN IF CAUSED, IN WHOLE OR IN PART, BY THE NEGLIGENCE OF THE "RELEASEES" NAMED BELOW.

HEREBY RELEASE, DISCHARGE, AND COVENANT NOT TO SUE USA TABLE TENNIS, their respective administrators, directors, agents, officers, officials, volunteers, and employees, other participants, any sponsors, advertisers, and if applicable, owners and lessors of premises on which the Activities takes place, (each considered one of the "RELEASEES" herein) FROM ALL LIABILITY, CLAIMS, DEMANDS, LOSSES, OR DAMAGES ON MY ACCOUNT CAUSED OR ALLEGED TO BE CAUSED IN WHOLE OR IN PART BY THE NEGLIGENCE OF THE "RELEASEES" OR OTHERWISE, INCLUDING NEGLIGENT RESCUE OPERATIONS; AND I FURTHER AGREE that if, despite this RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK, AND INDEMNITY

AGREEMENT I and/or my minor child, or anyone on my and/or my minor child's behalf, makes a claim against any of the Releases, I WILL INDEMNIFY, SAVE, AND HOLD HARMLESS EACH OF THE RELEASEES from any litigation expenses, attorney fees, loss, liability, damage, or cost which may incur as the result of such claim.

I HAVE READ THIS AGREEMENT, FULLY UNDERSTAND ITS TERMS, UNDERSTAND THAT I HAVE GIVEN UP SUBSTANTIAL RIGHTS BY SIGNING IT, AND HAVE SIGNED IT FREELY AND WITHOUT ANY INDUCEMENT OR ASSURANCE OF ANY NATURE AND INTEND IT TO BE A COMPLETE AND UNCONDITIONAL RELEASE OF ALL LIABILITY TO THE GREATEST EXTENT ALLOWED BY LAW AND AGREE THAT IF ANY PORTION OF THIS AGREEMENT IS HELD TO BE INVALID THE BALANCE, NOTWITHSTANDING, SHALL CONTINUE IN FULL FORCE AND EFFECT.

By registering for this table tennis tournament, all participants are subject to possible selection for drug testing as conducted by the US Anti-Doping Agency.

MEDICAL AND TRANSPORTATION RELEASE – I hereby give consent for the organizers of this table tennis tournament to provide me and/or my minor aged child with athletic trainer and emergency medical treatment. I swear and affirm that I am in good physical condition, and I am not aware of any previous or existing diseases or injury that would result in my being injured. I further acknowledge that I have procured on my own and currently hold valid and adequate insurance for such loss, damage, or injury and if I do not have valid and adequate insurance, I accept full responsibility for the cost of the loss, damage, or injury that might occur as a result of my participation in this table tennis tournament. I give my consent to participate in all emergency transportation associated with activities during this table tennis tournament, in the event I become incapacitated or otherwise not conscious to give direct consent and I accept full responsibility for all costs associated with all emergency transportation as deemed necessary. Further, as the parent/guardian of a participating minor athlete, I hereby give my consent for complete medical treatment and emergency transportation services as deemed necessary beyond the on-site athletic trainer or emergency medical treatment provided.

MEDIA AND PHOTO RELEASE – Any image, photographic, or otherwise, taken of tournament play or within the official venue is essentially the property of USA Table Tennis and CITTA regardless of the Approved status of the recording instrument or photographer. Entrants agree to allow their voice, video, pictures and likeness in such images/video to be reproduced in connection with USA Table Tennis by way of any medium. USA Table Tennis is not responsible for, nor can they control, the use of camera phones inside the venue. Participants are hereby notified of this policy.
