Rules and Policies

- > Tournament management reserves the right to modify, combine, or cancel events, limit total participants or total entries by event. If event is cancelled the fees for this event will be refunded.
- All matches are best 2 out of 3 games to 11 points.
- No prizes will be awarded to players for splits, defaults and no-shows. Default time is event/Match start time which is 6 pm. All matches must be completed on the same day.
- > To Win monthly Prizes players should have participated on two different Friday nights. All Matches from Week1 and Week 2 will be combined for final standings across all divisions
- > **Top 6 seeds** by rating (top six players expected to advance to Top Division 1) from the first week (Week 1 league) of the month will not be eligible to win prize money in Division 2 playoffs (2nd week) of the same month. If the top 6 seeds end up in Division 2 for week 2 by not finishing in the Top 4 of the respective 8-person group in first week, such players cannot win Prize money.
- Division 1 & 2: First (1st) week of the month, Top 16 players will play for Divisional play across two groups of 8 players each. Top 4 from both groups advance to Division 1 and the remaining 5-8 places will advance to Division 2. Week 2 of the month will be for divisional Play.
- ➤ **Division 3, 4 and 5:** First (1st) week of the month, Players ranked 17-40 will be placed in 3 groups of 8. Top 2 from 3 groups will advance to division 3, Players finishing 4th and 5th in respective groups will advance to division 4 and Players finishing 7 and 8th will advance to Division 5
- Division 3, 4, and 5: Players finishing 3rd and 6th in respective groups in the first week will be randomly selected, or by coin toss or by golden point for divisional play. Two of the three 3rd finishing players will advance to group 3 and 1 player among three 6th finishing players will advance to Division 4.
- Monthly Winners will be declared based on the combined results and standings of Week 1 and Week 2 of the respective months. All ties will be broken down using USATT rules for the two weeks.
- > The most recent USATT ratings available will be used for seeding the events on stadium compete ratings system. Players whose ratings get manually adjusted during season after first weeknight of the league will be automatically disqualified from winning awards and prize money for rest of the season including monthly and seasonal awards.
- > Note: Tournament committee reserves the right to deny prize money and/or awards to sandbagging players
- > Seasonal awards will be provided based on the combined results from all 6 weeks. Ties will be broken down using existing USATT rules across all matches played over 6 weeks.
- > Starting from Sept 5th, players who have not made the entry fee payment will be removed from the participant list automatically and the spot will be made open to the next paying participant. Platforms like Omni Pong and or stadium compete may not reflect the actual list of participants which are maintained Separately by CITTA organizing committee
- Players must register at the desk or check in online at stadiumcompete.com no later than 60 minutes before (5 PM) the start time (6 pm).
- > The Venue will be open for practice from 5:00 pm for league play. Pre-match warm-up will be limited to 2 minutes.
- > All events will be round robin in groups of 8 players if possible.
- Unrated players will be given an estimated rating based on a recommendation by a coach who knows the player or by visual evaluation of the player by a coach, whenever possible. Unrated players may not win prize money or trophies except for top division (1st 8th seed).
- Withdrawals through September 10th, 2025, will be eligible for full refunds.

- Purchase of Seasonal pass and/or weekly pass is not guaranteed for a spot to play in the league. Seasonal and weekly league pass holders still need to sign up for each week to play and check in at least 1hr (5pm) before play begins. Spots will be based on first come first serve basis. Open Spots after 5 pm Friday will be given to waitlisted players who are waiting at the venue.
- Season and Weekly passes are not transferable to another individual and cannot be applied or carried on to a different Season or week.


